# President's Message

For those of you who attended the August Civic Club meeting, I hope you all enjoyed it as much as I did. Judge Emmett was an excellent speaker and provided a lot of useful information about the role of the County Judge and how Harris County plays into our local government in general. It was an interesting presentation and we had a good turnout, including members of Candlelight Oaks and Candlelight Place Civic Clubs.

As August wraps up and we get into September, many of us will be taking trips or vacations before the school year starts again. As a reminder, please be extra vigilant during this period when you and neighbors are away from home for several days at a time. Random crime continues to be a pain to all of us. As an example, a theft of lawn equipment occurred in Section 1 this weekend, while the crew was actually there working. This should serve as a reminder for several things:

- 1) Most crimes in our neighborhood are crimes of opportunity. Limit the temptation to steal by securing your home, adding cameras, alarm signage, alarm monitoring, being vigilant, etc. Keep vehicles locked and garaged (if possible), and keep valuables out of sight.
- 2) Now more than ever, the constable program is critical. We need more homes to support it. For only \$20 per month, every homeowner can have peace of mind. It seems like a small price to pay to keep our neighborhood safe and secure. - 3) Finally, if you see any activity that is suspicious, please **call the constable**. They can be reached 24/7 at (713) 755-7628. Also don't forget to take advantage of the "Vacation Watch" where you can let the constable know about your travel plans and get an extra set of eyes to watch your property.

# Houston's Three-Foot Rule

Many of you know that I am an avid walker and now runner on our Garden Oaks streets. One of the wonderful advantages of our neighborhood is that we have long blocks that give us work out areas without dealing with cross traffic, and we have big old trees and shade that give the entire neighborhood a park-like setting without having to venture to one of Houston's great parks.

Most of the time, there's plenty of space for everyone. Most passing cars give pedestrians plenty of room, often driving in the oncoming "lane" (do our streets have lanes? I suppose technically they do) to go around us. I always really appreciate this and make an effort to acknowledge drivers when they do so. However, sometimes, a driver decides that they need to get by the pedestrian while there's another car coming towards them. It seems they think they have slowed enough to not mess up the pedestrian, but miss it entirely and we're all trying to get through the same point on the road at the same time. As the one fleshy object in the mix, that's not exactly a comfortable situation.

**You may remember back in 2013 that the City of Houston passed an ordinance that many touted as protecting cyclists on our roads by requiring drivers to give them three feet of clearance when passing (six feet for trucks). What a lot of people don't seem to realize is that the ordinance wasn't just for cyclists. It applies to what are called "vulnerable road users" — walkers or runners; the physically disabled, such as someone in a wheelchair; a stranded motorist or passengers; highway construction, utility or maintenance workers; tow truck operators; cyclists; moped, motor-driven cycle and scooter drivers; or horseback riders.**

I've had too many instances when I could reach out and touch the passing car with my hand. My arm is shorter than three feet long. That car was too close! I'm sure they wouldn't like it if I had driven that closely to them or someone they cared about.



# Civic Club Meeting Minutes

**August 1, 2017**

**Location:** Grace Church, 3754 N. Shepherd Dr

**Welcome and Introduction:** President Matt Gannon called the meeting to order at 7:12 p.m. Since this meeting also hosted attendees from surrounding neighborhoods, Mr. Gannon introduced the guest speaker prior to the business meeting.

**Guest Speaker:** Harris County Judge Ed Emmett has served as County Judge since March 2007. He provided a rough breakdown of the population density of Harris County. Roughly, 500,000 live inside the Loop 610 area, 1.5 million between Loop 610 and Beltway 8 and over 2 million live outside Beltway 8. There are 34 cities in the Harris County footprint. He joked that, as a County Judge, he is not an attorney and he works with four other county commissioners in a county court that is not a court. They have equal votes when setting county policy.

Judge Emmett stated that county government has focused largely on the outlying areas and he is now making an effort to visit different closer-in neighborhoods to educate them on how their office operates.

Nearly all of the finances utilized by the Commissioners Court come from property taxes and no sale taxes are available to them. Judge Emmett went on to explain what some of the line items in the property tax bill actually fund. Harris County has a AAA Bond rating and is in good financial shape. The first line item in the property tax bill is the HISD tax. It makes up the biggest percentage of the tax bill. Then comes the Harris County line item. Sixty percent or more goes towards criminal justice (jail, sheriff's office, courts); roads, bridges and parks make up the rest of the county tax expenditures. Harris County Toll Road system generates roughly two million dollars a day and that money has to go back into the toll road system to pay off the bond and for maintenance and expansion. Harris County Hospital District is the next item in the bill and is responsible for providing indigent healthcare. The district is trying to create more neighborhood clinics and teaming with groups to serve the population and focus on preventative care in order to lessen the use of emergency rooms. The greatest struggle for the county remains with how to handle mental health issues. Harris County Jail is the largest mental health facility in the state of Texas.

The Harris County Flood Control District was created in 1936 and is responsible for the main watersheds (bayous) in the county. The creation of MUDs (municipal utility districts) in the unincorporated areas of Harris County made it easier for developers to create the large neighborhoods that lie on the outskirts of the city without having to incorporate a flood control plan with the county. Therefore, when it rains heavily, that water is routed into the city and often overwhelms the existing drainage infrastructure.

Other jurisdictions include the Port of Houston Authority, the Harris County Dept. of Education and Houston Community College System. The Harris County Appraisal District has nothing to do with Harris County government. It is a political subdivision created by the State of Texas.

Judge Emmett spent some time answering questions from the meeting attendees to complete his presentation. More information can be found at [www.judgeemmett.org](http://www.judgeemmett.org).

**Civic Club Meeting Continued:** The business meeting portion of the agenda was called to order at 8 PM and a motion was made and passed to accept the June 2017 minutes as published in the *Gazette*.

**Treasurer's Report:** Teresa Coleman stated that the Spring Fling netted over \$10,000. Wine Walk sponsorship income is starting to come in and, at the time of the meeting almost \$5,000 has been received. The event is scheduled for October 21st and tickets will go on sale in a few weeks.

# Celebrate Peace!

Dr. Maria Montessori developed her approach to education through hands-on experiential learning. Core to her philosophy of education was teaching children peaceful ways to negotiate differences in their interactions with one another. As part of her classroom, she developed a Peace Table that is a hallmark of Montessori classrooms around the world.

Peace tables are just that - a child-sized table with two seats for children to sit alone or with a classmate to discuss a situation in a peaceful manner. The peace table is decorated with a vase and flowers to draw a child's attention to the peace and beauty of nature and encourage them to calm down and refocus. Children may be sent to the peace table to reflect on their actions or children may independently go to the peace table to discuss a situation that is causing conflict. Other elements of a peace table might include a small zen "garden" or tray of sand, a sand timer or other silent timer and/or paper to draw or write down their thoughts about what happened and what they might do differently the next time. At Garden Oaks, many of our peace tables have photos of Dr. Montessori or other notable peace makers like Dr. Martin Luther King, Jr and the Dalai Lama on them to remind us of leaders who made difficult choices to do the right thing.

You might find setting up a peace table in your home a useful alternative to "time out." We know that sometimes children become overwhelmed by the circumstances around them and may impulsively react in unacceptable ways. By helping them to visit a peaceful spot in your home, you can help them feel connected with you and supported in finding other alternatives to their automatic response. Debriefing with them and discussing different choices help children learn new strategies. You could use the acronym P.E.A.C.E.F.U.L. to discuss these strategies with your child:

P = Patience — Being patient helps us learn about others instead of focusing on ourselves.

E = Encouragement — Encourage others to try their ideas and try their best.

A = Acceptance — Accept that struggle and failure are part of our journey. We grow by trying.

C = Communication — Talk to other people and ask for help. Explain what you need.

E = Empathy — Show care and concern for others and they will reciprocate.

F = Fair — Be fair with others and have integrity. Stick up for others when you see injustice.

U = Understanding — Practice understanding by listening to other points of view.

L = Loving — Love the people around you unconditionally. We are all imperfect.

We will be celebrating the International Day of Peace at Garden Oaks on Thursday, September 21st. This day is also referred to as World Peace Day and is always celebrated on the 21st of September. # HISD Magnet Application Information for 2018-19 School Year

There is a lot of information to consider for the 2018-2019 school year. Magnet applications will be available online September 22, 2017. Phase 1 deadline is December 8, 2017. Applications submitted after December 8 will not be considered for the lottery, but will be placed on a waitlist in the order received AFTER the Phase 1 lottery waitlist.

## Choosing Schools

HISD Office of School Choice Fairs will be located at the following schools, and each fair is held from 9:00 a.m. – 12:00 p.m.

- September 30 at Milby HS
- October 14 at Westbury HS
- November 4 at Sterling HS
- December 2 at Key MS

Although hosted at various schools, **all** magnet schools are represented at each fair, so you really only need to attend one event. These school choice fairs are a great way to explore which schools would be a good fit for your child and determine which you would like to tour. HISD magnet schools will begin their tours Thursday, October 5. Elementary and K-8 school tours are for parents only and will be conducted at 9:00 a.m. each Thursday. Prospective students may accompany their parents on tours of middle and high schools which take place at 1:00 p.m. (These tours are scheduled in the afternoon so that prospective students who want to tour can be counted as present during attendance in the morning at their current school.) Tours will continue each Thursday through December 7.

## Applications

Applications will go live on September 22 with a deadline of December 8. This year, applicants can only apply to 5 schools. Please choose your schools wisely. I highly encourage parents to specify 5 school options rather than only 1 or 2 schools. As last year, you are

asked to rank your school choices, with the school in your #1 slot being your most desired and #5 being the least desired of the 5 choices. Please note: if you are applying to 5 Vanguard magnet schools and your kindergartener does not meet the Vanguard requirements, all of your applications for Vanguard will be marked as unqualified. Whatever you decide, make certain that you initial and click **submit** on your applications by December 8 to be considered for the lottery (Phase 1).

Applications that come in after December 8, but before May 31, will **not** be considered for the Phase 1 lottery, but rather placed in the Phase 2 application group. Once the Phase 1 lottery waitlists have been cleared (by parents accepting or declining spots), only then will Phase 2 applicants be considered for open spots. These Phase 2 applicants are offered open spots based on the time and date stamp on their applications. Applications received after May 31 and **all** Out of District Applicants are considered in Phase 3, and will be considered after Phase 1 and Phase 2 applicants have declined any remaining spots.

## Notifications

Status of the Lottery (acceptance or waitlist number) will be both mailed and posted to parent dashboards at the online application on March 22. Parents must respond to offered seats no later than April 5 if they are accepting an offered seat. Magnet Entrance Agreements must be turned in to the school when you accept an offered spot at this time, or have made arrangements to meet with the Magnet Coordinator from the school offering a seat to your child.

If you are notified of an offered spot after this time frame, parents have 3 days (72 hours) to accept the spot and turn in the Magnet Entrance Agreement. If, after 3 days there is no response, the spot will be declined and offered to the next applicant on the waitlist.

## Office of School Choice Definitions

"Offered" means that your child was offered a spot and you must accept or decline by the deadline.

"Waitlisted" means that your child is on the waitlist. Waitlists are created during the lottery after the number of seats available have been filled. Waitlist numbers move when students with offered spots decline their spot. Numbers can move down due to sibling preference. If a student accepts a seat and they have a sibling also on the waiting list, the waitlisted sibling moves to the top of the waitlist under any other siblings.

"Not Placed" means that your child's application was not part of the lottery. Perhaps you are zoned to the school you applied to, or your application was received after the deadline.

"Qualified" means that your child is qualified for our program and will be included in the lottery. (It does not mean that you are offered a spot.)

"Does Not Qualify" means that your child did not qualify for the program, most likely based on Vanguard testing.

(Note: Dual Language and Montessori programs have requirements for grades above grade 2. For the Dual Language program, it is a requirement that the students have the language in their background. For the Montessori program, students must have experience in a Montessori setting.)

The online application can be found at [www.hisdchoice.com](http://www.hisdchoice.com). You will need to create a user name and password; use an active email account as schools will contact you via email regarding applications and notifications. You will need to complete an application for any student who would be applying for a seat at any magnet school. Please make certain to include siblings on each of the applications.

If your family is zoned to Garden Oaks Montessori and you wish your child to attend in the 2018-19 school year, we kindly request you complete an online application. Our school zone includes Kindergarten – 5th grade. All Pre-Kindergarten and Middle School applicants must go through the lottery process. This will let us know how many spots to hold for our zoned students. Your child will not be placed in the lottery, but will receive an

acceptance. You will be notified via email to either accept or decline your offered seat. To see if your household is zoned to GOMM, please check here: [http://www.houstonisd.org/\\_findAschool](http://www.houstonisd.org/_findAschool).

Don't get me wrong - when I see the oncoming driver make the effort to give me time and or space, I am happy to make some effort/ on my part too. Sometimes, that is easier than others. For instance, if it has been raining, the easements are often wet and muddy, so it's hard for me to move over. Or there may be a big puddle limiting where I would prefer to go. But I do what I can.

That brings me to another point. Over the years, many have decided they want to protect the strip between the hard road top and their swale. Unfortunately, this gives pedestrians, bikes, and other vulnerable road users nowhere to go if a motor vehicle gets too close. There are properties that have plants, stones, or big rocks out front, and those make it tricky at best for someone who needs to quickly get out of the way of an inattentive driver. Personally, I would prefer if these were placed with consideration of people who might need to step or roll off the street for traffic.

Before you say it, I know that pedestrians need to obey the rules too. Just about all of the time, I do, and most people I see in the neighborhood do as well. However, as a person who has been on the "vulnerable" side of the equation, I want to remind our car-bound neighbors of that perspective. I'm not concerned about three feet or 35 inches, but that we remain aware and careful when passing vulnerable road users. By the time you read this, school will be back in session and we have many parents and children walking and riding bikes to school, as well as increased motor vehicle traffic. I hope that we all leave plenty of room for each other and share the road with a smile.

# Why Your Central Air Conditioner Leaks Water

As we all know, Houston air is loaded with moisture. While it's normal for your home's HVAC system to create some water as it dehumidifies the indoor air, a leaky A/C can be very alarming and cause significant property damage.

## Where does the water come from?

Water is a normal by-product of the cooling process. All air conditioning systems have an evaporator coil. It's basically a matrix of metal tubes that contain freon. As these tubes get cold, moist, hot air is blown across them; moisture collects just like it does on the outside of a cold can of soda. Eventually, enough water collects and then drips into the internal drain pan within the coil. Connected to the pan is the drain line that is made of PVC tubing that deposits the water into the plumbing or

outside of your home.

If something goes wrong with the drain pan or drain line, it can lead to water overflowing into the emergency safety pan located under the coil. So what causes this leaking water and what can you do to protect your A/C system and home from damage?

**The most common cause for leaking water is a clogged drain line.**

Over time, as water flows through the drain line, debris, algae and other particles begin to accumulate. Eventually enough of this gunk builds up so it completely clogs the drain line.

With no place to go, the water backs up and fills the evaporator coil's internal drain pan. If enough water is present, it fills the internal drain pan, then overflows into the emergency safety pan beneath the coil and spreads into your home's attic. Eventually, the water will soak through your ceiling. Now we're talking about serious water damage.

### Prevention is the key

**(1) Have an annual maintenance check-up performed.**

Make sure your A/C service technician clears the drain line as part of this check-up.

**(2) Invest in an overflow shut-off device.** Installed on the drain line, this clever gadget will turn off your A/C if the drain line becomes clogged and backs up. Most of the time, it will prevent water from overflowing the drain pan. Then call your service technician to clear out the clog.

**(3) Fix it yourself.** If you feel like tackling it yourself, pour a cup of bleach down the drain line's access port every couple of months to prevent a buildup of gunk. This is necessary only during peak summer months. Have your service technician show you where the access port is located.


