



Constable Program Update

Thanks to those of you who are current constable program supporters. If you are not, please consider contributing. We need you! Since we no longer have GOMO surplus funds paying for two of our constable contracts, the Garden Oaks Civic Club has signed new contracts for two deputies to patrol our streets starting in March 2017, but we need increased contributions and additional participants to keep those contracts in effect, as they are paid monthly. We do not currently have enough funds to pay for both of these contracts for the entire year.

Increased participation is crucial. Unfortunately, we will lose one of our current three deputies March 1st, and need your financial support to keep at least two deputies patrolling. It is up to the residents of Garden Oaks to pay for the constables. Each contract costs about \$77,000 per year.

As we go to press, only 245 households out of the 1430 homes in Garden Oaks are contributing at least the \$225 suggested minimum annual donation in 2017. That is only about 17% of all households in Garden Oaks. We still need more participation and funding in order to keep the Constable Program viable. The constable program benefits every single resident in the neighborhood, so please support the program.


Donating to the Constable Program can be done via the form in this month's *Gazette*, or online at gardenoaks.org. You can pay in one lump sum or monthly. There are many options online if you want to pay beyond the suggested \$225 annual minimum. **We really do need your support!**

- 1. Smoke 'n Spirits will be an opportunity to drink upscale liquors and smoke fine cigars and will be held April 8, 2017 at the home of Vidal and Debbie Martinez. - 2. The 9th Annual Wine Walk is scheduled for Saturday October 21, 2017 from 4 to 6:30 pm. The event will be a neighborhood/community wine and food tasting. Following the same format as in previous years, there will be 11-13 tables of wines and/or foods to taste, and we hope to include more neighborhood restaurants this year. Garden Oaks Civic Club Meeting Minutes

January 3, 2017

Location: Garden Oaks Montessori Magnet School (GOMM), 901 Sue Barnett

Welcome and Introduction:

President Matt Gannon welcomed those in attendance and called the meeting to order at 7:06 p.m. Mr. Gannon asked for a motion regarding the minutes for the December 2016 meeting. Brenda de Alba moved to accept the minutes. Teresa Coleman seconded the motion and the vote passed to accept the December 2016 minutes as published in the January 2017 Gazette. Mr. Gannon then introduced the new Civic Club officers for 2017: Jim DiCola (Vice President), Teresa Coleman (Treasurer) and Joe Casarez (Secretary). The 2016 Civic Club officers were recognized and thanked for their service to the community and presented with gift cards to local restaurants. 2016 **GOCC President Sheila Briones** accepted the gift cards on behalf of the officers who were not in attendance (Chris Lindsay VP, Jerry Butler, Treasurer, Luke Sustr, Secretary and Mark Klein, Government Affairs).

Prior to the guest speaker, Chris Markos from My House Fitness (18th/TC Jester) provided the two door prize drawings: one for four individual training sessions (won by Joe Muscara) and the other for four semi-private small group training sessions (won by Brenda de Alba).

The guest speaker was Erin Thole (formerly Palmer) CNHP (Certified Natural Healthcare Practitioner), who gave an informative and timely presentation regarding the benefits of a healthy eating regimen. Ms. Thole focuses on the root cause of health issues via food sensitivity, hormonal, and toxicity panels to figure out what works best for each individual client. She talked about the importance of regulating hormones, especially leptin. It was a very detailed, informative presentation with quite a bit of interaction answering the questions from those in attendance.

Treasurer's Report: Treasurer
Teresa Coleman had hard copies of
the organization's current profit
and loss statement and balance
sheet available to attendees. Ms.
Coleman reported that 2016 was a
good year as a result of the Garden
Oaks Home Tour and an increase in
the number of households joining
the Constable Program. The GOCC
net income for 2016 was
\$66,863.50.

COMMITTEE REPORTS

Constable Program: Program
Chair Terry Jeanes indicated that
the GOCC has signed two
constable patrol contracts for 2017.
She also asked for additional
volunteers to assist in contacting
GO households who previously
participated and to sign up new
contributors in the Constable
Program. 2016 ended with a record
level of about 370 households

participating in the program. A level of 400 to 450 households would be preferable so as not to have to rely on fundraisers as much. Since GOCC is committed to providing two constables, it is important to get as many households participating in this very beneficial program for the neighborhood.

Officer Eric Oliver said that over the holiday season, there were two household burglaries and the suspects were apprehended both times. Charges against a package thief have also been filed.

The constables also thanked the generosity of the GO residents who contributed to the Christmas Toy Drive.

Membership: Committee Chair Dian Austin reported that 2016 ended with 292 civic club members. To date in 2017, there are 178 paid civic club members. Starting 2017 there are 245 households supporting the Constable Program, down from a high of 370 contributing households in 2016. Brenda de Alba suggested a couple of billboard-type thermometers in each section to show current constable participation levels. Social media was also suggested to bring awareness of the need to increase Constable Program support.

Garden Oaks Citizens' Patrol:

Program Chair Carl Waters, Jr. reported five crimes from the HPD website for the month of December. Of the five crimes, four occurred during Christmas week. Mr. Waters also requested volunteers to help patrol the neighborhood and if interested, to please contact him via the GOCC website. Patrollers must be 18 years in age or older and pass a background check with the Houston Police Department.

NEW BUSINESS

Terry Jeanes provided more information on a recent planning meeting for a new Constable Program fundraiser: Smoke 'N Spirits. The cigars and adult beverages fundraiser will be on April 8th 2017, to be hosted at the Vidal and Debbie Martinez home. Approximately 125 tickets will be sold. Sheree' Peoples has volunteered to chair the

committee. Terry Jeanes motioned to form a task force for hosting the GOCC-sanctioned event to raise money for the Constable Program. Sheila Briones seconded the motion, and the motion passed.

Dian Austin stated that the 9th Annual Wine Walk, also a Constable Program fundraiser, is scheduled for Saturday October 21, 2017. It will be an open event to all who purchase a ticket and who are at least 21 years of age. The 2016 Wine Walk raised \$30,000 for the Constable Program.

OTHER BUSINESS

GOMM Principal Dr. Lindsey
Pollock gave an update on the
school's construction project with
regard to the Spark Park, where a
rock base is being created for the
trucks to drive on so that heavy
equipment can be brought in.
Land clearing is taking place
followed by work on the two
temporary buildings and some
abatement. February 4th is the
date for the annual GOMM
Pancake Breakfast and Auction.

Coley Groth asked about the status of repairing the Garden Oaks signs at neighborhood entrances. Sheila Briones stated that the company contracted to do this would have the signs repaired by the end of the month, weather permitting.

Frances Schwartz asked if the GOCC had interest in donating to the Friends of Oak Forest Park.

November meeting speaker Elyssa Horvath, with the Friends of Oak Forest Park, had discussed the building of an all-accessible park for inclusive use by the kids and

parents with disabilities. Lori Kennedy made a motion to request the GOCC donate \$2,500 to purchase twenty-five 6x6 clay tiles that would be painted by the students of GOMM and placed at the park. Brenda de Alba seconded the motion. Before the vote, there was additional discussion regarding how this would be funded, and Ms. Kennedy withdrew her motion. Terry Jeanes moved to table the vote until the next civic club meeting so that more research could be done to get clarity on the funding of the motion and to reach out to the Friends of Oak Forest Park group for more information.

President Gannon indicated that he was in the process of confirming a speaker for the February meeting.

The meeting was adjourned at 8:30 p.m.

Reviewed a total of 48 Plan Proposals for 32 Projects

- 21 were approved at first review
- 7 were approved on review after revision
- 4 were denied and not resubmitted

Reviewed a total of 27 Member Reported Deed Restriction Violations

- 7 were determined not to be violations
- 16 were removed by homeowners at GOMO's request
- 1 is pending removal; owners have agreed to correct
- 1 is receiving further review
- 2 are awaiting attorney opinion

Involved in litigation

- A case on the subdivision of a Section 1 lot. This case ended after an appeal to the Texas Supreme Court was denied. The lot will remain as is but may not be erected upon.
- A second case involving the other half of the subdivided lot is expected to be resolved soon.
- Garages in Section 3. This case is on appeal with an expected decision in 2018.



A Letter To GOMM Parents

Dear Parents,

Recently, you may have heard about a new system for rating schools in Texas. House Bill 2804, passed by the Texas Legislature in 2015, will change the Texas school accountability system so that every campus and district will be rated with letter grades. The new system will go into effect in the 2017-18 school year.

Much like students receiving individual subject grades that are combined for a grade point average, the law requires schools and districts to be issued grades based on five different areas of performance, and those five grades are combined into a single overall rating. Using data from the upcoming 2017-2018 school year, schools and districts will be given an overall rating of A, B, C, D, or F, along with A-F ratings in five separate domains.

The Texas Education Agency (TEA) recently released a provisional report showing ratings HISD schools would receive in Domains I, II, III and IV if the A-F rating system had been in place during the 2015-16 school year.

The provisional grades for GOMM were released as follows:

Domain I: Student Performance C STAAR Scores

Domain II: Student Progress D STAAR and ELL Progress between Racial/Ethnic Groups

New 2017-2018 School Accountability System FAQ

Starting with the 2017-18 school year, the Texas Education Agency will give each public school and district a rating in the form of an A-F letter grade to comply with House Bill 2804 passed by the 84th Texas Legislature in 2015. HISD has compiled these FAQs to answer some of the questions you may have about this upcoming change.

Q: How will schools and districts be rated under the new system?

A: Much like students receive grades in individual subjects and those are combined for a grade point average, the law requires schools and districts to be issued grades based on five different areas of performance, and those five grades are combined into a single overall rating. The five areas or domains are: Student Achievement, Student Progress, Closing the Gaps, Postsecondary Readiness, and Community and Student Engagement. Based on the 2017-2018 school year, schools and districts will be given an overall rating of A, B, C, D, or F, along with A-F ratings in the five separate domains.

Q: How are schools rated currently?

A: Under the current school accountability system, which went into effect with the introduction of STAAR testing in the 2011-2012 school year, Texas schools are rated either Met Standard or Improvement Required. Prior to that, schools were rated Exemplary, Recognized, Academically Acceptable, or Academically Unacceptable, depending on their TAKS scores.

Q: What factors will be used to rate a school or district under the A-F system?

A: The new rating system will focus on how well schools are doing in three main areas: preparing students for success after graduation, reducing achievement gaps, and informing parents and the community about district and campus performance. More specifically, STAAR test results are projected to be roughly 55 percent of a school's grade. Other factors may include: high school graduation rate and diploma plans; credits for Career and Technical Education (CTE); completion rate of AP or IB courses; and postsecondary credits achieved through the HISD dual-credit program. Factors new to the system include the number of students who enlist in the U.S. Armed Forces; school attendance rates; middle school dropout rates; and the percentage of students receiving instruction in college and career preparation. An additional 10 percent may be based on community and student engagement, another new indicator.

Q: What do the "provisional" ratings that were released in January 2017 mean?

A: The Texas Education Agency recently released a "provisional" report showing the ratings HISD schools would have received in Domains I-IV for the 2015-2016 year **if the A-F rating system was currently in place**. These ratings are available at TEA.Texas.gov, but keep in mind the current system rates campuses as either *Met Standard* or *Improvement Required*. The provisional ratings will be used to guide discussion for further development of the new system. In addition, HISD will analyze this data to continue our work improving all schools.

Additionally, there's a discount on air conditioning and furnace parts. Also, you do not have to pay extra for emergency repairs or Saturday service calls.

Another benefit a PMA provides comes when you sell your home. Most PMAs are fully transferable to the new homeowner, and that can be a big plus in your home's favor.

What About Warranties?

I've had customers ask why a PMA is necessary since his or her home's A/C system and furnace are covered under the manufacturer's warranty. In this case, a PMA is still recommended because it helps keep the warranty valid.

Most manufacturing companies of HVAC equipment require that you keep a maintenance history on the A/C system and furnace. If you don't, the manufacturer's warranty can be voided for failure to properly maintain the equipment. The inspections conducted during the Spring and Fall create that maintenance history and make sure your home's A/C system and furnace run at peak performance. A little preventative maintenance goes a long way!

Noodle On This

You may have seen, heard about, or even tried the new spiral vegetable noodle craze. I have been following this concept for a while, thinking I would experiment. Always looking for new and tasty ways to get our boys to enjoy and ingest more vegetables and fiber in their diets, these noodles seemed to be a good idea. Some would agree that I am not usually an early adopter, but I did eventually try it, using my old fashioned grater to make long noodles. I usually don't like a lot of fancy gadgets taking up extra space in my kitchen as I am a pretty simple cook. However, I found myself reading Amazon reviews and kitchen bloggers hoping to find just the right tool.

At an investment of \$15.00, I talked myself into it. I finally bought a hand held spiralizer and admit I do like it so far. At this point though, I believe I would enjoy the counter top crank model better now that I have used it many times. The hand held takes a fair amount of strength, especially with carrots or sweet potatoes. We have eaten a few more servings of vegetables with this new gadget, and that was my goal; stronger forearms are a nice benefit though!

While at the store wavering over this item, I spied a cookbook: Inspiralized: Turn Vegetables into Healthy, Creative, Satisfying Meals. Imagine a whole cookbook devoted to vegetables cut in this unique way. Thankfully, we can

find books on just about anything that sparks our curiosity. I am sharing this recipe with you from Ali Mafucci's book and website. I found it surprisingly easy and delicious. As usual, I changed it up a bit. I left out the turkey pepperoni and used fresh mozzarella that lightly browned on the convection setting in my oven. I think the iron skillet is key to giving the sweet potatoes a crispy bottom. I also don't use olive oil with heat so I substituted with butter.

Spiralized Sweet Potato Pizza Bake

Prep time Cook time Total time 15 min 30 min 45 min

Serves: 4

Ingredients

For the sweet potatoes:

- 1 tablespoon extra virgin olive oil
- 2 medium sweet potatoes, peeled, Blade C
- Salt and pepper, to taste
- 1 teaspoon garlic powder

For the casserole:

- 1.5 cups marinara sauce (I like Rao's)
- ½ teaspoon dried oregano
- 1.25 cups shredded mozzarella cheese
- 12 turkey pepperoni slices
- 2 tablespoons chopped basil, to garnish
- 1 tablespoon grated parmesan cheese, to garnish

Instructions

1. Preheat the oven to 425 degrees and grease a 10" cast-

- iron skillet or square casserole dish.
- 2. Place a large skillet over medium-high heat and add in the olive oil. Once oil heats, add in the sweet potato noodles and season with salt, pepper and garlic powder. Let cook for about 5 minutes or until noodles begin to soften.
- 3. Transfer the cooked noodles to the casserole dish and pour over the tomato sauce.

 Sprinkle the dried oregano over the tomato sauce evenly and then layer over with the mozzarella cheese. Place the pepperoni slices on top in rows.
- 4. Bake in the oven for 20-25 minutes or until cheese melts through and is slightly golden brown.
- Remove from the oven, garnish with basil and parmesan cheese.

For those of you keeping up with the details, this dish has all your RDA for vitamin A, half of what is recommended for calcium, and is high in protein. Granted, it is higher in carbohydrates at 25g a serving, but delicious nonetheless. If you want another way to use sweet potatoes after all your traditional holiday meals, maybe this one will be a good try. Enjoy!
