DECLARATION OF WALKER & PATTERSON, P.C. PURSUANT TO 11 U.S.C. § 327 AND FED. R. BANKR. P. 2016

- 3. To the best of my knowledge, information and belief, formed after due inquiry, W&P has no known relationship with the Debtor, its creditors, other parties in interest, their respective attorneys and accountants, the United States Trustee or any person employed by the Office of the United States Trustee.
- 4. Except as set forth above, W&P has no other known connection with the Debtor, its creditors, any other parties-in-interest, its respective attorneys and accountants, the United States Trustee or any person employed in the office of the United States Trustee and is a "disinterested person" within the definition of Section 101(14) of the Bankruptcy Code.
- 5. Subject to the approval of this Court, W&P will charge the Debtor for its legal services on an hourly basis in accordance with its ordinary and customary rates. All attorneys and paraprofessionals employed by W&P are assigned hourly billing rates that are adjusted periodically and may change during the course of W&P's employment in this case. Any

The rate of each professional will be clearly reflected in W&P's monthly invoice(s) and

billed in six minute increments as required in the Southern District of Texas. W&P will

maintain detailed records of time spent by professionals and their respective activities.

6. Disbursements for expenses are not included in W&P's hourly rates and will be separately

billed as expenses of this proposed engagement. Such disbursements for expenses shall

include, without limitation, charges for photocopying, courier services, document retrieval

costs, printing, computer-assisted legal research (Westlaw/Lexis), postage, long distance,

telecopier, deposition fees, filing fees, witness fees, subpoena fees, parking fees, tolls, travel

expenses (including mileage), and any fees for outside contract services. In certain cases,

charges are set by the service providers or outside contractors and in other cases.

7. Prior to the filing of these cases, W&P received a retainer of \$50,000.00 from Garden Oaks

Maintenance Organization, Inc. as security for payment of services to be rendered. This

amount has been reduced by W&P's pre-petition fees and expenses, including the filing fee

for this case. The balance of the retainer was \$40,003.00 as of the petition date. Walker &

Patterson was paid \$9,997.00 for current billings in March and April, 2018, which included

the filing fee of \$1,717.00.

members of the firm) for the sharing of compensation received for services to be rendered

in connection with this representation.
