



TAX PROTEST

STILL!

Local taxpayers, including members of this Civic Club, have banded together since last March, under the name TAX PROTEST GROUP. The first action of this group was a meeting at Delmar Stadium. Since that time, money has been collected with the sole purpose of fighting the inequities of Houston's tax reevaluation system. After a few months, we fell short of our \$6,000 goal and the idea of a law suit against the City of Houston was dropped. The next plan, put into effect August 1, was a petition drive to collect signatures to force consideration of an ordinance that would effectively limit property taxes. There are two petitions being passed. The Green petition is a City of Houston Charter Change that would limit taxes to 1/2 of 1% of fair market value (or 50¢ on each \$100 of valuation), allow no increase in taxes until the entire city has been revalued; and limit tax increases to a maximum of 10% per year. The Gold petition proposes an ordinance that freezes all valuations at 1977 levels until the entire city is brought up to date. The TAX PROTEST GROUP is aiming at over 40,000 signatures to assure success. The group has its headquarters at 1249 North Loop West, phone 868-7494. Please contact them to donate time or money or to answer any questions you may have. As of this date(August 15th), we are awaiting a decision by the city legal department on the legality of the Mann Proposal passed at the first meeting of the tax equalization board. This

proposal IF ACCEPTED would provide for a sliding scale of limitations on '78 reevaluations. In Garden Oaks the increases would be limited to a 6% increase over your '77 evaluation, due to the six year span since we were last re-valued. There being much doubt on the legality of this proposal we urge you to continue to support the TAX PROTEST GROUP and see this through to the end.
