We are asking YOU to help your police help you. Houstonians On Watch - "HOW" - is simply a program of neighbors watching other neighbor's property during vacation periods, the working day, evenings, or during any absence. The program works through the mutual aid of neighbors. Each neighbor can only effectively watch the homes on each side, the front and the back. For the program to be totally effective, each resident must take an active role in both security and observation. YOUR HOME! OBSERVE YOUR NEIGHBORHOOD! Anything that seems even slightly "out of

place" for the area or during the time of day in which it occurs MAY mean criminal activity.

The organization of "HOW" is in no way a vigilante group. It leaves the responsibility of apprehending criminals where it belongs - with the police! No one is asked to be a hero. Neighbors are asked to be alert, observant and caring. When suspicious activity occurs in the neighborhood, you notify the Houston Police Department Dispatcher at 222-3131. It is not necessary to be a member of the Garden Oaks Civic Club to participate in this program. "HOW" is for the mutual benefit of everyone in Garden Oaks.

Your Block Captain will contact you and will have two booklets, "Crime Prevention for the Homeowner" and one detailing the "HOW" program. An engraver is available to help you mark and indentify your valuables. "HOW" is a proven deterrent to crime.

On July 21, 1980 the City of Houston, representing residents of Garden Oaks, was granted a permanent injunction against Special Delivery Service operating from the owner's home at 223 W. 33rd. The operation of the business from the home did not stop as was required and contempt of court charges were then filed. On September 2, 1980 Judge Thomas J. Stovall found the defendant guilty of contempt and assessed a fine of \$500.00 or three days in jail.
