# Wine Walk Coming October 20

Plans are underway for our 10th annual Garden Oaks Wine Walk, our premier Constable Program Fundraiser. This event is a wine and food tasting extravaganza held in the huge and lavishly landscaped backyard of a Garden Oaks couple. The Wine Walk will be held on Saturday, October 20, from 4 to 6:30 pm, with all proceeds going to help fund the Constable Program.

Our theme this year is "Cheers to Ten Years", celebrating wines of the world and all the folks who have been with us on our fundraising journey. We have raised some \$162,000 via this fun neighborhood event over the past nine years. Last year alone, we raised around \$32,000!

We will have 12 wine and food stations situated throughout the venue, with 11 tables being returning table hosts from previous years. The 12th table will be a Plonk! special beer tasting. We will also be featuring a Wine Pull this year.

Tickets will go on sale September 1 on Eventbrite, and will be priced at \$85. We will only sell 200 tickets and we have sold out every year, so get your tickets early.

Crime Stats Inch Up, Second Constable Patrol May End

At the July Civic Club meeting, the Treasurer showed a projection of available Constable Program funds. The projection showed an inevitable loss of the second Constable Patrol deputy next year, leaving the Garden Oaks neighborhood with only one deputy patrol as soon as the end of 2019. Reserve funds will no longer be available.

As noted in the Citizen Patrol Update elsewhere in this issue, crimes are up in Garden Oaks. That was true last month as well.

The bottom line is that funds must increase. The Civic Club contracts with the Harris County Precinct One Constable's office for the patrol deputies. Each contract is paid entirely from residents' contributions. Each contract costs about \$77,000 annually. The current two contracts end February 28, 2019. If adequate funds are not flowing into place, the ability to contract for more than one deputy will fade away in 2019.

# Back to School Safety

It is back to school time and that means school zones will be in effect!

Garden Oaks Montessori serves children 3 years old to 8th grade.

Our **new** school hours for the 2018-19 school year are 8:30AM - 3:50PM, Monday - Friday.

Here are some safety reminders for driving in school zones from the National Safety Council:

- Put away your cell phone. Cell phone use is banned in active school zones, and violators face fines of up to \$200 in school zones where signs are posted.
- Don't block the crosswalk when stopped at a red light or waiting to make a turn, forcing pedestrians to go around you; this could put them in the path of moving traffic.
- In a school zone when flashers are blinking, stop and yield to pedestrians crossing the crosswalk or intersection.
- Always stop for a crossing guard holding up a stop sign.
- Take extra care to look out for children in school zones, near playgrounds and parks, and in all residential areas.
- Don't honk or rev your engine to scare a pedestrian, even if you have the right of way.
- Never pass a vehicle stopped for pedestrians.
- Always use extreme caution to avoid striking pedestrians wherever they
  may be, no matter who has the right of way.

If you're driving behind a bus, allow a greater following distance than if you were driving behind a car. It will give you more time to stop once the yellow lights start flashing. It is illegal in all 50 states to pass a school bus that is stopped to load or unload children.

- Never pass a bus from behind or from either direction if you're on an undivided road – if it is stopped to load or unload children.
- If the yellow or red lights are flashing and the stop arm is extended, traffic must stop.
- The area 10 feet around a school bus is the most dangerous for children; stop far enough back to allow them space to safely enter and exit the bus.
- Be alert; children often are unpredictable, and they tend to ignore hazards and take risks.

On most roads, bicyclists have the same rights and responsibilities as vehicles, but bikes can be hard to see. Children riding bikes create special problems for

drivers because usually they are not able to properly determine traffic conditions. The most common cause of collision is a driver turning left in front of a bicyclist.

- When passing a bicyclist, proceed in the same direction slowly, and leave 3 feet between your car and the cyclist.
- When turning left and a bicyclist is approaching in the opposite direction, wait for the rider to pass.
- If you're turning right and a bicyclist is approaching from behind on the right, let the rider go through the intersection first, and always use your turn signals.
- Watch for bike riders turning in front of you without looking or signaling; children especially have a tendency to do this.
- Be extra vigilant in school zones and residential neighborhoods.
- Watch for bikes coming from driveways or behind parked cars.
- Check side mirrors before opening your door.

By exercising a little extra care and caution, drivers and pedestrians can co-exist safely in school zones.

# GOCC Ad Hoc Section 1 Commercial Development Committee

There has been some activity around the potential development in our neighborhood. Garden Oaks Baptist Church wants to sell its parking lot on the west side of Shepherd between Gabby's and Chase Bank to Gulf Coast Commercial Group for commercial development. For the sale to happen, those lots must be released from the Section 1 Deed Restrictions. The Church and Gulf Coast have proposed a Declaration of Restrictions to replace the current Deed Restrictions for those lots.

The Section 1 Commercial Development Committee's (the Committee or CDC) primary goal is to work with the homeowners, the Church, and Gulf Coast to determine if the neighborhood is willing to release the lots from the current Deed Restrictions. We also have a secondary goal to lay out a reasonable template if other homeowners or commercial-lot owners seek to be released from the Section 1 deed restrictions.

In early May, the CDC met with Patrick Barry of Gulf Coast and Jim Coit from the Church, among others, and the Committee voiced our initial concerns.

Since that meeting, the CDC has met with an attorney and an urban planner/architect to review the proposed Declaration of Restrictions. The attorney and urban planner/architect suggested changes to the Declaration of Restrictions, including reasonable restrictions on noise, lighting, trash pick-up times, and trash locations and provisions on landscaping and sound wall, among other things. They also may include provisions to ensure that the agreement runs with the land and for amendment of the restrictions.

Patrick Barry from Gulf Coast requested a meeting to present the CDC with a new proposed rendering and an

amended Declaration of Restrictions. On Friday, July 13, a meeting was held with Mr. Barry; his business partner, Tom Lile; Kent Marsh, the Committee's urban planner/architect; Matt Gannon GOCC President (as requested by Mr. Barry); Andrea Joseph; and myself. At the meeting, Mr. Barry provided a more specific rendering of proposed development and an amended Declaration of Restrictions.

The CDC is cautiously moving forward with the developer. Although some of the initial concerns were addressed, there are other concerns about which no agreement has been reached and other concerns that haven't been fully addressed. In the coming weeks, the Committee will review documents provided by Mr. Barry, and will continue to consult with the urban planner/architect, our attorney, and Section 1 neighbors to make any changes that may be required to protect the neighborhood. The Committee's intention is that we will provide a response to Mr. Barry in mid-August.

The CDC has been approached by a real-estate broker who represents Salata, a salad bar with other locations throughout the city. If the lots are commercially developed, Salata has interest in being one of the tenants. They were contacting us to find out if Salata would be "well received by the community, given the discussion going on about changing the deed restrictions." They shared that they "are not open past 9 pm, do not sell alcohol, and will not have a drive thru." Please let us know your thoughts.

# Garden Oaks Civic Club Meeting Minutes

July 10, 2018

Location: Garden Oaks Montessori Magnet School

Matt Gannon, Civic Club president, welcomed attendees and called the meeting to order at 7:02 pm.

**Guest Speaker**: Johnie Patterson, GOMO bankruptcy attorney, was the guest speaker. He stated that the most significant new development is the appointment by the court of a Creditors' Committee. This committee, which is not part of GOMO nor the Civic Club, was formed to represent the interests of the unsecured creditors.

The Creditors' Committee, made up of five Garden Oaks residents has hired an attorney, and the committee has filed a lawsuit against GOMO, asking the court to rule that GOMO must stop collecting transfer fees and cease all deed restriction enforcement activities. The court will determine if this is a viable request. GOMO funds are being used to pay for the Creditors' Committee attorney and for the lawsuit.

Mr. Patterson emphasized that creditors need to make the Creditors' Committee aware of how they want the GOMO funds distributed. If the Creditors' Committee does not hear from homeowners, then they will do what they believe is best. Objections can also be submitted to the Trustee regarding a Creditors' Committee member. Submit comments and questions via email at GOCreditorsCommittee@gmail.com. Keep a record of your correspondence. You can also email Mr. Patterson.

Matt invited the Creditors' Committee members to participate in the discussion. Four of the five resident Creditors' Committee members were present: Gary Ingram, Sue Schmidt, Cheryl Luck, and Trish Merhkam. Committee member Peter Chang was not at the meeting. Charles Rubio, the Creditors' Committee attorney, introduced himself and reiterated that this is a Chapter 11 bankruptcy, one in which a manager stays in possession of the assets, but develops a plan to redistribute the assets back to creditors. Mr. Rubio stated

that the Creditors' Committee lawsuit requested a stop to both collection of transfer fees and a stop to enforcement of deed restrictions in order to maximize returns to the creditors.

Mr. Patterson defined a creditor in a bankruptcy case as someone who has a claim (whether it be for services, performance, or money) against the debtor. In the GOMO case, creditors are not limited to homeowners who have paid transfer fees, but they are the overwhelming majority. Anyone who has paid the GOMO transfer fee must submit the claimant form, subject to judicial review, to be considered a creditor and to potentially get reimbursement of those monies. (The claimant form can be found on gardenoaks.org.)

To date about 30 claimants have filed for reimbursement of monies. The list of current claimants should be on the Garden Oaks website shortly.

Mr. Patterson stated that he will oppose the Creditors' Committee lawsuit against GOMO.

Written questions were submitted by those in attendance and were read and discussed.

When asked how much the Creditors' Committee lawsuit has cost to date (paid for by GOMO funds), Mr. Rubio said he did not know, but that the fees are based on hourly rates. His fee is \$475 per hour, and his associate's fee is \$325 per hour.

When asked why the Creditors' Committee did not inform the neighborhood of their formation when they filed May 31 and did not ask for input before hiring an attorney and filing suit against GOMO, Mr. Rubio defined the process for forming the committee. The Trustee of the court received applications for members on the committee, and after reviewing them, decided who would be appointed to the committee. This information is public.

When asked how Creditors' Committee member Peter Chang was able to file a \$114,000 claim against GOMO, Mr. Patterson stated that the courts will decide what claims are valid. Filing a claim does not ensure its validity.

A request was made for each Creditors' Committee member present to address their credentials for being

on the committee. They declined. Mr. Rubio repeated that the US Trustee made the decision as to the members on the committee, and only the Trustee has the ability to remove and add members.

When asked if the Creditors' Committee has open meetings, it was stated that the meetings are closed by choice, not by requirement.

#### **Business Meeting**

A motion to approve the June minutes was made and seconded. Minutes were approved. New attendees introduced themselves.

**Treasurer**: Teresa Coleman provided a mid-year overview of the Civic Club finances. (The June report is posted on the website.) The Civic Club income fails to meet the budgeted target by about 30%, largely due to overly-optimistic projections for the 2018 Home Tour and ad revenues from the *Gazette*.

Teresa reiterated that the Civic Club maintains two bank accounts, one for the Civic Club (~\$93,000 balance) and a second one specifically for the Constable program. Income and expenses are tracked independently.

The Civic Club has currently contracted for two constable patrols. While we are currently in deficit spending, there may be enough funds to pay for two constable patrols through 2019, assuming the 2018 Wine Walk brings in the projected \$30,000 and residential contributions continue at the current rate.

Since the Civic Club no longer receives any surplus GOMO funds for beautification purposes (expenditure was voted on by GOMO members but stopped in 2017), many related projects have stalled. In some of the neighborhood parks, sprinkler systems are shut-in, leaking or saddled with inadequate timers. Planting makes no sense without adequate sprinkler and water resources. Teresa moved that the Civic Club take up to \$5000, out-of-budget & from reserves, to repair and enhance the pocket park sprinkler systems. The motion was seconded and approved.

#### **Committee Reports**

GOMO: No report.

Constable: Terry Jeanes introduced Deputy Chris Byrd,

the newest constable deputy. He grew up in Acres Homes and has served in Precinct 7, the Heights, and as a toll road deputy. Terry encouraged all to donate to the Constable Program, attend the Wine Walk, and pledge fees back to our community.

**Beautification**: Joan Harmon thanked the members for the \$5000 to repair the sprinkler systems . She stated that some Spring Fling money will be used to make repairs to the GO Boulevard irrigation system.

**Garden Oaks Website**: Pam Parks reported that the website changes often, with new information being added on the GOMO bankruptcy and related topics as available.

Citizen Patrol: After 22 years, Carl Waters will retire as the Citizen Patrol Chair at the end of this year and needs someone to replace him. Thirteen crimes, all thefts, were reported last month. Eight thefts were in the 200 block of W 34th. Only six neighbors are currently members of the Citizen Patrol. Anyone who is 18 or older, lives in Garden Oaks, passes a background check and completes a one hour training class can join the Patrol. Please volunteer and help keep our community safe!

**Membership**: Dian Austin stated that there are currently 259 paid Civic Club members and 329 paid Constable Program supporters. Joanie Harmon won the \$25 gift card in the raffle.

**Wine Walk**: The committee is actively seeking sponsors for the October 20th Constable Program fundraiser. Terry Jeanes-Re/Max Metro and Oak Forest Veterinary Hospital are the first two sponsors of the 2018 Wine Walk, whose theme is "Cheers to Ten Years".

*Gazette*: Joe Muscara said the deadline for August *Gazette* articles is July 15. Lori Kennedy still needs a delivery person for the 200 block of W 30th.

Garden Oaks Montessori Magnet School: Stephanie Acosta said school starts August 27. Those living within the GOMM boundaries and having a child K-5 were encouraged to contact her if wanting the child to attend GOMM. Otherwise, the limited slots will be open to the 1250 others on the waiting list.

**GO Reform:** Matthew Houston and his team have been working on a short survey, which will gauge what type of

deed enforcement entity, if any, neighbors want, post GOMO. The survey (digital or hardcopy TBD) will consist of eight questions and will be ready soon. Respondents are asked to submit results by August 20th. The GO Reform Committee and the Creditors' Committee are two totally separate entities. Currently, the GO Reform group has 10 active volunteer members.

Section 1 Commercial Development: Carrie Arnett and Andrea Joseph will meet with the Gulf Coast Commercial Group developer soon. He will present renderings and a revised declaration of restrictions. An urban planner will also attend the meeting.

#### New Business: None

The meeting was adjourned at 8:30 pm. Next month's meeting is slated for August 7 at 7pm. No guest speaker is scheduled. Instead, the meeting will be a forum for discussion of the GO Reform survey HOA options and any available results.

# Creditors' Committee Letter

The letter on pages 13 and 14 is "a reprint of the exact letter the Garden Oaks Creditors Committee sent out specifically to the individual unsecured creditors in the first week of July regarding GOMO's chapter 11 bankruptcy case."

Dear Current or Former Garden Oaks Property Owner,

In April 2018, the Garden Oaks Maintenance Organization (GOMO) filed for Chapter 11 bankruptcy protection in response to appellate court findings that the organization had been improperly formed and it is not authorized to collect transfer fees.

You have been identified from a potential list of approximately 1,600 creditors in that proceeding. In order to be formally considered as a creditor in the case, you will need to file the attached proof of claim form with the bankruptcy court by <a href="August 27th">August 27th</a>, <a href="2018">2018</a>. This form (Form 410) is also available on the GOMO website, <a href="www.gardenoaks.org">www.gardenoaks.org</a>, and the U.S. Bankruptcy court site, <a href="Form 410 Proof of Claim">Form 410 Proof of Claim</a>. The completed form, along with the settlement statement showing your transfer fee paid or other evidence to support your claim should be sent to:

United States Bankruptcy Court Attn: Case 18-60018 P.O. Box 61010 Houston, Texas 77208

As part of the normal Chapter 11 bankruptcy process, the U.S Trustee has appointed a creditors' committee (the "Committee") to represent the interests of the unsecured creditors in this case. The U.S. Trustee invited the top 20 creditors to participate on the Committee and several other members of the community applied. A five-member Committee was selected on May 31, 2018 from those creditors that agreed to make themselves available to serve. The Committee represents the unsecured creditors; consults with the debtor (GOMO) concerning the administration of the case; investigates the acts, conduct, assets, liabilities, financial condition of the debtor and operation of the debtor's business; and, of utmost importance, participates with the debtor in the formulation of a chapter 11 reorganization or liquidation plan for GOMO. The court may also authorize the Committee to employ one or more attorneys, accountants, or other agents in the discharge of its duties.

Committee members participate voluntarily and are not compensated for their time. The Committee's expenses are paid from the debtor's estate (GOMO). These expenses include legal representation in addition to administrative and support expenses approved by the court. This Committee represents the interest of the creditors during proceedings in the bankruptcy case. At the advice of the U.S. Trustee the Committee obtained legal counsel, selecting Diamond

McCarthy LLP, a Houston-based law firm that focuses on business bankruptcies. Ultimately any proposed chapter 11 plan is subject to approval by the creditors with claims, against the debtor, that are allowed by the court.

GOMO has retained bankruptcy counsel, Johnie Patterson, also at the expense of the debtor's estate. Mr. Patterson represents the interests of GOMO, which the Committee believes to be retention of the approximately \$600,000 in cash and other assets for potential transfer to a new or reorganized property owner's association. Prior to the establishment and selection of the Committee and without the participation of any creditor in the bankruptcy case, the debtor sought and obtained the approval from the bankruptcy court of an operating budget and authority to cash transfer fee checks. The transfer fee checks held since the chapter 11 filing have been deposited into the GOMO account and the collection of transfer fees currently continues.

The Committee is currently focusing its efforts on four issues: (1) stopping the current collection of transfer fees, (2) seeking input from creditors for a chapter 11 plan (3) understanding GOMO's current financial situation and (4) preparing a chapter 11 plan that will get the required support from the creditors. Because GOMO does not have the authority to collect transfer fees, the continued collection of transfer fees will likely add to the list of parties to be repaid and increases the bankruptcy administrative expenses for GOMO. The Committee is of the opinion that the individual residents and non-residents that have funded GOMO should be refunded to the extent possible and be afforded the choice whether or not to support another property owners' association. It is imperative that all parties work toward a timely solution to avoid exhaustion of all available funds in bankruptcy administration. The Committee is considering options for a chapter 11 plan that could result in a refund or partial refund of transfer fees paid before and after the bankruptcy filing. Importantly, the only way you will potentially be eligible for a refund is to submit a proof of claim form. We have attached a proof of claim form for your convenience.

This is important to the community moving forward and to the individuals that have funded GOMO. Please consider filing your proof of claim form and look out for future notices regarding the bankruptcy as this case moves forward. # How the Evolution from R-22 to R-410A Refrigerant Affects You

If you've had to repair or replace your A/C system recently, you've probably heard about alternative refrigerants in use today. These new products generate fewer chlorofluorocarbons (CFCs) and are designed to have less impact on the earth's ozone layer. While some of them go by names such as Prozone or Puron, they are all R-410A. Today, R-410A is the dominant refrigerant, playing a crucial role in our current and future A/C systems.

In 2010, the Environmental Protection Agency (EPA) enacted policy requiring all A/C manufacturers to stop producing systems that use ozone-depleting R-22 refrigerant. For decades, R-22 refrigerant has been the standard in the HVAC industry.

#### What does the R-22 phase-out mean to consumers?

If your A/C system develops a leak, replacing the freon may be necessary. If it uses R-22 refrigerant, your system can be recharged with R-22 up to January 1, 2020, if R-22 can be found.

R-22 is becoming scarce, and the price has risen from \$35 to over \$150 per pound in less than ten years. After January 1, 2020, refrigerant manufacturers must cease all production of R-22 and produce only the more environmentally friendly R-410A refrigerant.

The Clean Air Act does not allow any refrigerant to be vented into the atmosphere during installation, service or retirement of equipment. Therefore, R-22 refrigerant must be recovered and reclaimed to be processed to the same purity levels as new R-22 or be destroyed. After 2020, the servicing of R-22 systems will have to rely on recycled refrigerants. This means the price of R-22 will continue to skyrocket.

#### Should I switch to a R-410A system now?

If you need to purchase a new A/C system, you're in luck. Not only is it more environmentally friendly, R-410A also has a higher cooling capacity compared to R-22 and superior heat exchange properties. This results in greater efficiency overall within a more compact system that use less refrigerant compared to outdated R-22 equipment.

# Garden Oaks Montessori Middle School

## Lindsey Pollock, Ed.D., Principal, Garden Oaks Montessori

Did you know that Garden Oaks Montessori starts enrolling students at 3 years old and provides instruction through the 8th grade? Yes, our students have the opportunity to experience an authentic Montessori learning environment through the 8th grade at Garden Oaks. What makes our middle school program unique?

The Garden Oaks Middle School Program is focused on our 7th and 8th grade students. Traditional middle schools start with 6th grade, while Montessori learning environments maintain the 3-year community through 6th grade (that means 4th, 5th and 6th graders are together in the same classroom). Then students move to an integrated 7th and 8th grade learning environment where students are focused on interdisciplinary units of study as they prepare for high school and beyond. Additionally, our program is very small compared to comprehensive middle school programs, so students who thrive in close-knit learning environments do especially well.

The Montessori curriculum for 7th and 8th grades is largely project-based and hands-on. Adolescents prefer to learn through social interaction and practical application. Students have a strong desire to see for themselves how their studies relate to them and their lives. This is why you often hear, "When will I ever use this?" or "Why do I need to know this?" Montessori instruction in middle school environments empowers students by helping them find these connections.

Our program is developed to meld the students' natural motivations and interests while ensuring that minimum state requirements are met or exceeded. Our adolescent Montessori program provides hands-on, interdisciplinary, project-based elements that address all the major subjects: Mathematics, English, History and Science.

Mathematics is facilitated through the integration of a variety of curricula including GoMath, Saxon Math and Montessori materials as well as online resources. To develop a deeper understanding of math, students use manipulatives to explore how Algebra was developed and is applied. Math is studied as a unified system of analysis. Math textbooks are used to practice techniques learned and to solidify concepts. Students may take Algebra I and Geometry for high school credit if they qualify by a written exam and teacher recommendation.

**English** is studied as a means of communication. Through written expression, applied reading techniques and oral communication practice in all subject areas, students study the English language as a vital tool of communication with others.

**History** is explored through a combination of direct instruction and student-developed projects. US and Texas history are studied in relation to the student and their place in history.

Science is addressed in terms of occupation and application. Our new, state-of-the-art science lab is designed for hands-on learning and will provide an enhanced classroom in which to work and extend information to a real-world context. Our pond, outdoor gardens, chicken coop and composting provide additional learning spaces for students exploring how our work directly impacts the world.

Field trips and service projects are an important part of the Montessori adolescent curriculum. Our internship model is one of student service in the community. Students will travel in groups in December and May to agencies in the Houston area to volunteer and learn about career options. If you are connected to an agency (including non-profits and faith-based settings) that would be interested in having our students come to volunteer, please contact me at lpollock@houstonisd.org Additionally, our middle school has adopted the esplanade along Garden Oaks Blvd as a volunteer project. Our middle school students also mentor younger students on campus through our Reading Buddies Program, where middle schoolers are paired with younger students for a regular afternoon reading time.

Additionally, middle school students participate in

elective courses including Physical Education/Health, UIL Academic Competitions, Computer and Technology Applications (Coding and Robotics), Art, Mandarin language studies and our Magnet Elective with an emphasis on global connections. Students who did not pass STAAR reading and/or math the previous year or who are failing reading/math in the current year will participate in reading and/or math electives. You may be wondering about sports. We do offer UIL middle school soccer for both boys and girls. Students who wish to participate in other after-school activities may go to their zoned school as long as the sport/activity is not offered at their magnet school campus.

Starting this year, eighth grade students complete a capstone project and present it as a culminating activity. Most of the 8th graders will have spent between eight and eleven years at Garden Oaks! We celebrate students' achievements and recognize their aspirations at the end of the year ceremony as their bridge to high school and beyond. We are delighted to watch our middle school program expand as we move into our new classrooms and lab spaces. Not only does the renovated space have new computer and science labs, but we also have a brand-new art room with a kiln. Garden Oaks'

construction is nearing completion as we approach the 2018-19 school year. Thanks to all for your support and patience through this exciting process!


