## GOMO's Revised Bankruptcy Plan

GOMO has revised its plan that will be the basis for its starting point in a joint negotiation with the Creditors' Committee or possibly a separate plan to be resubmitted and voted upon by the neighborhood. These are general principles and subject to revision after potential negotiations with the Creditors' Committee.

#### 1. A flat, simple transfer fee of \$1500.

This will be assessed on *future*, *and not current*, property owners and will include a reasonable adjustment mechanism so it may be lowered or raised based on future needs of the neighborhood. Discontinue the current 0.75% transfer assessment on sold property that is the basis of the current transfer fee. Abandon the prior contemplated \$80 annual fee proposal. Current property owners will not pay any fees. The judge was adamant that GOMO include a mandatory annual fee in its earlier plan. However, with the voting results in hand, we are comfortable standing up to the judge and recommending a transfer fee on future property owners be maintained, but significantly lowered, and improve the method so as to address the concerns of residents regarding the ability to adjust it in the future.

#### 2. Maximize money returned to creditors.

After attorney's fees are paid, post-petition fees returned, and 1 year reserve of operating expenses for the future HOA are set aside, 100% of remaining funds will be returned to creditors. It is our objective to ensure our plan maximizes the funds returned to creditors.

#### 3. Update deed restrictions and bylaws.

Neighbors, we need these updates. Some of the current restrictions are untenable and must be revised/updated. On this point there is very little disagreement. There must be a reasonable amendment process, sorely lacking in the current DRs, to allow the DRs to evolve moving forward. Had a workable and reasonable amendment mechanism been in place, the neighborhood could have easily voted years ago whether it wanted to amend or remove certain restrictions that weren't equitably established and enforced through all sections of GO. The existing method requiring an affirmative vote of 67% of all neighbors is too high a threshold and a difficult task. That is why the DRs have

## Bankruptcy Plan Voting Results

Below are the tallied results from GOMO's recent bankruptcy plan vote that ended April 1, 2019. The Class 5 results are believed to be the most significant and sure to have the greatest influence on the bankruptcy court judge based on his prior comments during public hearings, because Class 5 reflects the interests of those residing within and maintaining a continued stake in the future of Garden Oaks. Note that Class 5 includes homeowners who are a mixture of both non-creditors and creditors.

The Class 5 vote was effectively split, 50/50, and consequently the GOMO Board chose not to seek confirmation of the plan by the bankruptcy judge. A primary goal of exiting bankruptcy has been to bring resolution and closure to the neighborhood in regards to its HOA, and seeking confirmation of this plan in light of split results would have done the opposite, only serving to incite further discord.

Despite being a split vote, some useful insight into homeowners' priorities was gained. Multiple ballots were returned with supplemental text stating the voter would have voted for the plan if not for the inclusion of the \$80 annual fee. Neighbors, particularly those who have already paid a fee, clearly do not wish to pay another fee nor is there much appetite for the annual assessment. Many Class 3 creditors are also homeowners voting in Class 5, and through their votes it was made clear that receiving maximum value of any monies to be returned to creditors was a priority. Although we believe that updated deed restrictions with a reasonable amendment method to facilitate future revisions are integral to the future success of the HOA, clearly this was not as highly prioritized as 1) Maximizing monies returned to Creditors and 2) Minimizing monies that must be paid out by Homeowners in the future.

What now? Without a confirmed plan, GOMO remains in bankruptcy. More cost, more pain, but hopefully a better plan will emerge that may unify and receive full backing from the neighborhood. Representatives of GOMO and the Creditors' Committee met during the voting period, and both groups' attorneys continue to be in discussion about ways to move forward, hopefully with a unified plan. The next bankruptcy court hearing is set for May 9, 2019, although there is a possibility it could be earlier if GOMO and the Creditors' Committee reach an agreement on a jointly acceptable plan.

not been updated. The GOMO Board strongly advocates capitalizing on this opportunity to update and revise our DRs and bylaws under the protection of and as part of the bankruptcy case to more easily ensure and facilitate timely passage.

#### 4. Fix GOMO formation defect.

#### 5. GOMO leadership resigns upon plan confirmation.

The new HOA Board that will be elected after bankruptcy is completed will consider the benefits of third party professional management for deed restriction enforcement. It is the GOMO Board's belief that ensuring a professional, objective process for DR enforcement would allow the neighborhood to move forward with greater confidence, but feedback at prior town hall meetings and the voting results suggest this is not the most pressing priority for the neighborhood.

## Garden Oaks Civic Club Meeting Minutes

April 2, 2019

Location: Garden Oaks Montessori Magnet (GOMM)

Joe Casarez, GOCC President, called the meeting to order at 7:06 pm.

**Guest Speaker**: Doug Waldrep, Development Director of BikeHouston (bikehouston.org), was our guest speaker. BikeHouston is a non-profit (501c3) organization dedicated to encouraging and educating cyclists of all ages. Working with the city, law enforcement, and other organizations, they ultimately hope to make Houston a comfortable, healthy, cycling city by enhancing safety laws and creating a network of connected streets and trails.

One major effort is the "Build 50 Challenge", a campaign to build 50 miles of bikeways in 12 months. To date, about \$10 million has been secured and 36 miles have been completed. BikeHouston's continued advocacy and momentum (400+ volunteers, 1400+ members, 23,000+ supporters) will ultimately give Houstonians access to high comfort bike lanes. Remember to give cyclists 3 feet of safe clearance when you pass them. It is the law.

Two BikeHouston future fundraising events include the "Moonlight Ramble", an annual ride scheduled for October 19, 2019 and the "Bike Summit", a May 17, 2019 luncheon followed by free street demos on May 18, 2019.

An informative Q&A followed.

#### **Business Meeting**

A motion to approve last month's minutes was made and seconded. The minutes were approved.

#### **Committee Reports**

**GOMO**: Joe Casarez reported that votes on GOMO's plan are being tallied. The next hearing date is slated for Tuesday, April 9.

Treasurer's Report: No report.

**Constable Patrol**: Terry Jeanes has found someone to create thermometertype signs that will show the current level of support vs. our goal for the Constable program. Anticipated completion of signs is two weeks. Two constables visited and spoke.

Beautification: No report.

**Garden Oaks Website**: Pam Parks reported that the site is updated daily. Check www.gardenoaks.org.

**Citizen Patrol**: Mark Saranie said that patrollers are still needed. Two incidents, one in section one and another in section four, were reported. Kudos to Deputy Joe for always looking out for the neighborhood.

Membership: Dian Austin reported that there are currently 224 paid civic club members and 239 constable supporters. The committee is working on "New Neighbor" welcome packets to distribute to new residents. Contact Membership@gardenoaks.org if you would like to help.

**Garden Oaks Montessori Magnet**: Linda Kelly reported that the GOMM dedication is scheduled for April 4, 2019 at 10 am and all are invited. Guests will include Mayor Turner, the HISD superintendent, and local and national representatives.

**Government Affairs / GO CIP:** Tonya Knauth reported that nearby infrastructure issues, such as needed street repairs, can be reported by calling or emailing 311 or Council Member Ellen Cohen's office.

Section 1 Commercial Development: Carrie Arnett emailed that Gulf Coast Development has submitted their plat application to the city. It will take 6-8 weeks to process. A public hearing will be held on April 11. Carrie's understanding is that the re-plat is a requirement for closing, but will not affect the Declaration of Restrictions. The anticipated closing date for sale of the property is sometime in May, 2019.

**New Business:** A "letter to the editor" policy was defined for the *Gazette*. Editor Joe Muscara reviewed policies from local and national newspapers. Some discussion

followed. A motion was made and seconded that the *Gazette* have formal guidelines for letters to the editor. The motion was passed.

The new policy will include that letters shall not exceed 250 words, must be written by a Garden Oaks property owner or resident, must contain the author's full name and contact information (address and phone number, for verification purposes only) and will be rejected outright if libelous or profane. The editor's discretion will be used in determining if a letter is published.

The next GOCC meeting will be held on May 7, 7 pm, at GOMM. Lauren Simpson of St. Julian's Crossing Wildlife Habitat, will be our guest speaker.

The meeting was adjourned at 8:19 pm.





## My Favorite Air Filter Ever

So, which is my favorite air filter and the one I recommend most often? It is the **dust lock integration or DLI filter**. The DLI filter allows air to flow freely through it. Good air flow is absolutely essential as it prevents the coil from freezing or the heat exchanger from overheating.

The DLI filter traps up to 90% of airborne particles beginning at 7-10 microns\* in size. For example, mold spores are 10-30 microns. It accomplishes this while allowing a free flow of air that is critical to the well-being of your A/C system.

#### Different is better

DLI filters are made of an antimicrobial, polyester media that effectively controls the growth of mold, mildew, algae, and fungi within it. What makes a DLI filter different and better is that the surface of the individual fibers are uniformly coated with a non-toxic, environmentally safe adhesive. Additionally, it will not migrate nor dry out. As your A/C system pulls air through the DLI filter, it removes the airborne particles. Trapped by the adhesive, they are held within the filter permanently.

I have personally witnessed a demonstration where an entire cup of dirt was poured into a DLI filter and not one speck came out the other side. Dust, pollen, and pet hair don't stand a chance.

DLI filters are approximately one-inch thick and custom cut to fit your A/C system. They are held in place with a wire grid that your service technicians can install. The filters are a very reasonable \$5.00 to \$8.00 apiece and come in a bag of 12. You can replace them yourself.

#### Simple is good and so is change

While simple in design (no complex pleating here), a DLI filter does its job very well and lasts at least one month, sometimes longer, depending on how many airborne particles you have indoors. Children, pets, and carpeting produce a lot of dust, dander and hair. With them in the house, I would replace the filter monthly. If you have no children or pets and have hardwood floors, it may last two to three months. A great rule of thumb is if you see dust on the white side of your DLI filter, it's time to replace it.

\*Micron - One micron is one-millionth of a meter. There are 25,400 microns in one inch. Airborne particles that you can see start at about 40 microns.
