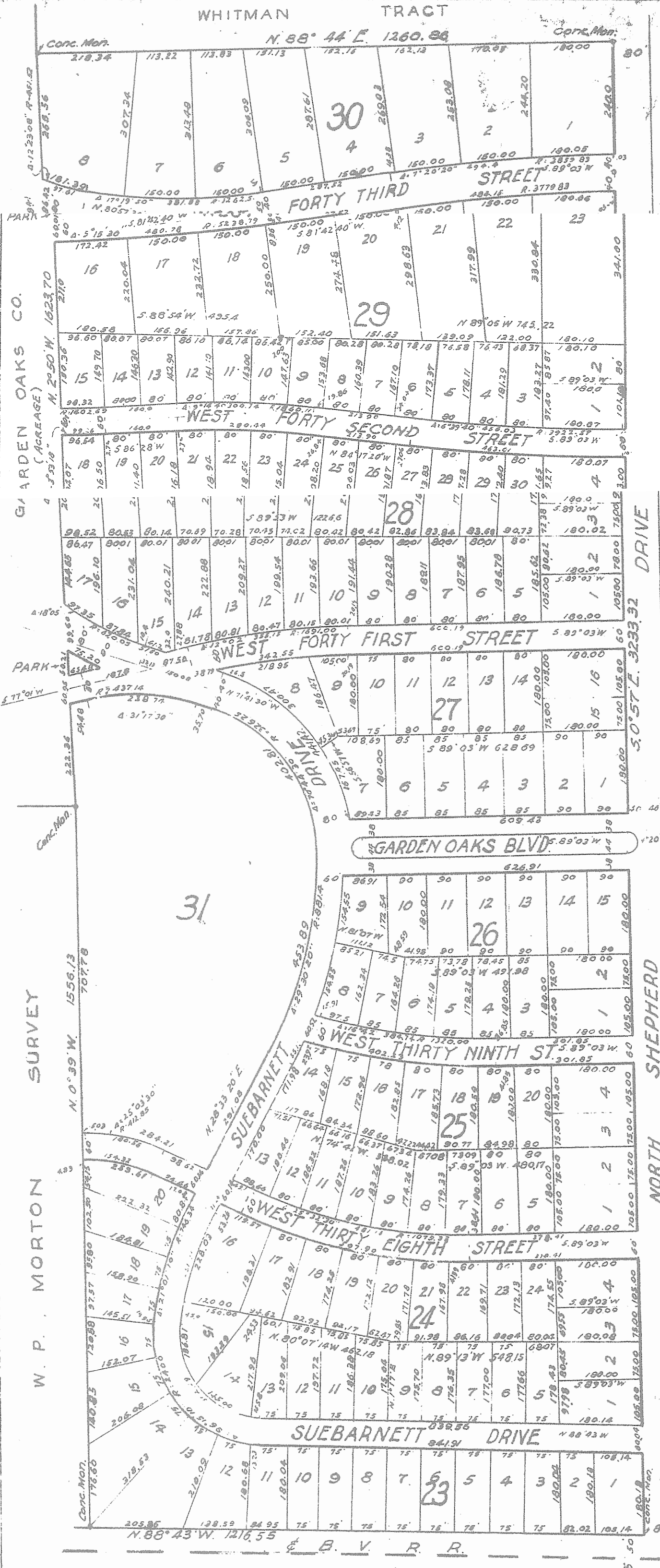




Garden Oaks
