ORDER SUSTAINING TRUSTEE’S OMNIBUS OBJECTION TO CLAIMS
[Relates To Docket No. _____]

Upon the objection (the “Objection”) of the Chapter 7 Trustee (the “Trustee”) for entry of an order (this “Order”) sustaining the Omnibus Objection, all as more fully set forth in the Objection and the Declaration of the Chapter 7 Trustee, Randy Williams; and finding that:

1. this Court has jurisdiction over this matter pursuant to 28 U.S.C. § 1334;
2. this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2);
3. that it may enter a final order consistent with Article III of the United States Constitution;
4. that venue of this proceeding and the Objection in this district is permissible pursuant to 28 U.S.C. §§ 1408 and 1409;
5. the relief requested in the Objection is in the best interests of the estate, its creditors, and other parties in interest;
6. notice of the Objection and opportunity for a hearing on the Objection was appropriate under the circumstances and no other notice need be provided; and

7. the legal and factual bases set forth in the Objection and at the hearing on the Objection establish just cause for the relief requested.

The Court additionally read findings of fact and conclusions of law into the record, and based upon the findings and conclusions in this Order and on the record, it is

ORDERED that the Objection is sustained as set forth herein, and it is further

ORDERED that Claims identified on the attachment are disallowed in their entirety, and it is further

ORDERED that the Clerk shall update the claims register to reflect the disallowance of the identified claims.
