Daniels Speaks on Changes at Garden Oaks Elementary

Jeannie Daniels, the new principal at Garden Oaks Elementary, spoke at the October Civic Club meeting about the changes taking place at the school. She started off by saying that an effective school is one in which all the children are learning and can learn. It is also one in which the test scores are high regardless of race and socio-economic background. Daniels quoted these national statistics: Of the children born in 1986, 24% live below the poverty line and only 4% have working fathers and stav-at-home mothers. One very important observation made by Ms. Daniels is that children have changed dramatically, but the ways they are taught have not. Elementary school is basically the same today as it was when we, our parents, and even our grandparents were in school. She went on to describe seven characteristics of an effective school:

- 1. Strong, instructional leader a leader of leaders, who will take an active role a the school and make instruction top priority.
- 2. Focus on instruction that we all share the same vision and commitment.
- 3. Holding high expectations by principal, teachers, parents, and community and believing that we can attain those expectations.
- 4. School climate a safe, orderly, clean environment which leads to a high morale.
- 5. Using assessment appropriately compare scores based on sex, race and socio-economic backgrounds and use those findings to do something about low scores.
- 6. Campus resource allocation fixed assets - are they used in the most effective way to raise morale?
- 7. Parental and community involvement -here Ms. Daniels quoted an old African proverb, which sums it all up: The education of the young is the job of the whole village.

Every citizen of Garden Oaks should think about this bit of wisdom. We should incorporate it into our daily lives and ask ourselves what we as individuals and as a group can do to educate the voung of Garden Oaks. Their future is our future.



Notes From the Garden

We hear a lot of talk these days about the fragility of the ecosystems that surround us. Everything from our backyards, to Galveston Bay, to the earth itself seems to be imperiled. I wouldn't begin to argue that the dangers don't exist, but I do have a problem with the tone of some of the commentary. Media reports tend to describe our natural environment as a delicate and fragile old parchment-one which will crumble into dust if we so much as touch it.

Ecosystems are fragile only in the sense that it doesn't take much of a shock to change a system. It takes one heck of a wallop to destroy one. From very personal experience in the garden, I can assure you that Mother Nature is one tough old biddy-and she doesn't go down without a fight.

A few weeks ago I was ready to fill one of the beds in the new garden with soil. The ground in the bottom of the bed had a pretty good stand of nutgrass and bermuda grass. Since I didn't want the weed grasses infiltrating the bed, I put down an overlapping layer of newspapers about eight sheets thick over the whole bed, under the frame of the bed, and two feet out around all the sides of the bed. Then I filled the bed with six inches of soil and mulched the side areas with a three inch layer of grass clippings. Two weeks later, I had nutgrass and bermuda pushing up through the surface. The newspapers and six inches of dirt didn't even slow them down.

In an earlier column, I harped on the evils of herbicides (chemicals that kill plants). I pleaded for people to avoid them unless you were faced with a really big problem. Well, the weeds in the garden finally got the better of meand I broke down and bought some Roundup. I mixed up a full strength patch and sprayed the entire garden area (after reading and carefully following the directions, of course).

Three weeks later, the Roundup had destroyed most of the vegetation, but a

funny thing had happened. In a number of spots where the nutgrass and bermuda had died back, two totally new varieties of ground cover had appeared and seemed to be spreading rapidly. The additional space and light encouraged plants which wouldn't have survived in the earlier conditions. Some of the original villains remained as well, and if I don't keep them under control they'll take back over in no time. My efforts to kill the plant half of the ecosystem had failed rather pathetically.

The lesson is clear. Natural systems are durable, adaptable, and opportunistic. It's also important to remember that nature also does not discriminate in humanity's favor. If we mess up an ecosystem, nature will probably rebuild it, but we may not like the new one nearly so much as the old.

I am so proud of our G.O. C.O.P. patrolling record. You are out in force and it shows! Area 1 patrolled 33-1/2 hours for September, Area 2 patrolled 84 hours, and Area 3 patrolled 117 hours! Keep up the G.O. C.O.P. force!

Everyone has been asking me "How did the Heights Festival go?" Well, it went great! We had a festive Heights Festival Booth thanks to Linda Same and Nancy Rust who decorated with a very special C.O.P. scarecrow and neon signs. They also manned the booth along with Heather Barr, Patrick King. Sue Pagel, Johnny Murphy, Bill & Jinny Chastain, Nell & Wayne Armstrong, Mildred Worhol, Joan Fudge, Anita Scherer, Angela Dickson, Tom Mehrkam and of course, was there! We had a great time selling Blue Bell Ice Cream sandwiches and canned Coke products donated by Apple Tree on 43rd. The profit from both festivals so far is approximately \$330. H.P.D. & C.O.P. WorkingTogether

The H.P.D. and the Northwest Area O.P. Coordinators and Assistants met ctober 12th for a workshop on Organizing for Growth, Scheduling, Recruiting, Preventing Burnout, and Fundraising - all the behind the scenes criteria needed to have a successful C.O.P. program. Tom Merhkam joined me to represent G.O. C.O.P. along with 17 other Northwest neighborhood C.O.P. leaders. Sgt. Guidry from H.P.D. and Sherri Perry, Shepherd Forest Subdivision Coordinator presented the workshop. This was the first such workshop between a police force and organized C.O.P. groups in the country. Sat. Guidry hopes to establish a coalition with the participants of the workshop to continue the effort and work with neighborhood C.O.P. programs throughout the city of Houston.

Another very exciting and innovative program was announced October 15th in a news conference with Chief Watson and the president of Houston Cellular Telephone Company. Houston Cellular has donated 15 cellular phones to H.P.D.

rastudy of the value of cellular phones versus CB radios and base stations in C.O.P. patrolling. We are one of fifteen neighborhood C.O.P. programs chosen to receive a cellular phone! The program should be underway in November and the phone in our hands - or I should say our cars! We will be sharing the phone amongst our patrollers and will feedback to H.P.D. the success, value, etc., of our experience with the phones. If they prove to be effective and efficient for patrolling, we will be issued cellular phones instead of CB radios and base stations in the future. The phone time is free, but only 3 numbers will be accessible; 911, 222-3131 (H.P.D. dispatch), and our area substation. Patrollers will have a training session and will begin to use the phones sometime in November. Immediate access and contact with H.P.D. will make a safer and more efficient patrol.

In conjunction with better equipment, such as the celluar phone program, many new ideas were discussed at the October 12th workshop. We discussed the "no-man's land" areas-the business areas around our neighborhoods, such as the Ella & 43rd intersection, the back alley behind Ella Blvd. businesses, North

Shepherd, 610 feeder, etc. It was suggested to expand our patrolling to include these areas and encompass our business community in our patrol. Many pros and cons were discussed and H.P.D. is going to study this possibility further before including it in the C.O.P. guidelines. So for now, no decision has been made and we are to continue patrolling in our neighborhood only and take the signs off our vehicles when leaving the neighborhood.

A joint effort was encouraged between neighborhood C.O.P. groups to "blanket" this side of town with patrollers; to get to know our neighbor programs and people involved for better patrolling efforts. H.P.D. is trying to include this as a joint venture project amongst area C.O.P. groups. I will keep you informed of any news and hope those of you who are interested will call me for more information.

One last opportunity I would like to pass along is the Ride Along Program. If you want to ride with an officer during the day, you may walk into the substation and make your request at the front desk. If you want to ride at night, please call the substation to make an appointment to patrol with the officer. H.P.D. requires you to sign a waiver for responsibility and then you may ride with an officer. I suggest to all that have an interest to please take advantage of this community service and follow up with a note to me about your patrol ride. I would like to share your experience with the Gazette.

Houston is making history as the first city with a police/citizens workshop, the first to consider and hopefully organize a coalition, and the first for a cellular phone program for area C.O.P. groups. You are also making history by being a part of our G.O.C.O.P. program everyday! Houston will take back its city and you can help it happen. Get involved!

Texas Legislative Update

Several new laws have come into effect recently that affect our pocketbook. Here is a list of some of these tax changes made in the regular and special sessions of the Texas Legislature.

Effective September 1, 1991:

... a \$2 fee will be assessed on all retail sales of new and used lead-acid batteries of at least 6 volts but less than 12 volts and a \$3 fee on lead-acid batteries of 12 volts or more. The revenue generated by the fees will be used to recycle the lead and acid in batteries and the battery cases which are usually made of hard rubber

... the motor vehicle sales and use tax rate will increase to 6.25%. Motor vehicle rentals for 30 days or less will be taxed at 10% and rentals for more than 30 days. will be taxed at 6.25%. The definition of motor vehicle has been expanded to include trailer dollies, stingers, auxiliary axles and converter gears.

... proof of insurance will be required when renewing or obtaining a driver's license, automobile registration (license tags), and inspection stickers.

Effective October 1:

... boats under 65 feet long usedprimarily for non-commercial use and outboard motors will be taxed 6.25%. The seller and purchaser both will sign a form available from the county tax office or the Parks and Wildlife Department stating the amount paid for the boat and/ or motor. The tax will be paid to your local county tax assessor-collector or to the Parks and Wildlife Department when applying for boat registration and/or title.

... motor vehicle repair shops, body shops and garages will be allowed to buy consumable supplies for resale and collect tax from their customers provided customers are charged separate amounts for parts and labor.

... the tax rate on gasoline and diesel fuel will increase to 20 cents per gallon.

... the list of taxable services will be expanded to include all telephone answering services and the repair. maintenance, and restoration or remodeling of boats and motors.

Effective January 1, 1992:

... a \$2 fee will be assessed on new tires sold. Most of the money generated by the fee on tires will be distributed to professional tire shredders to encourage recycling.


