It might be fours rooms, at the most! The mother does not drive and neither parent can read or write Spanish or English. FROM THE EDITOR

I couldn't do a story on the Exxon proposal without including my personal opinion, so I am making it a part of my last editorial as Editor of the Garden Oaks *Gazette*.

The minutes report for the November meeting shows that a committee (Rich Stark, Ed de Alba, Kim McMath) is negotiating with Exxon. President Ed de Alba and Committee Chairman Rich Stark reported on their negotiations. During these negotiations, (de Alba reported), Exxon implied that they could take us to court and win if the variance to sell alcohol was denied. Exxon's argument being that Taco Cabana and Gabby's were given variances, so why not them? Since Exxon claims to be a good neighbor, I was concerned by their remark.

I wrote to Helen Huey, our city council representative, and asked her to check with the City Attorney's Office to see if Section One residents voted no on the variance question, would these residents have any protection from the city? Mrs. Huey replied (by phone) that her office would support the deed restrictions, and if necessary petition the Mayor to lodge a protest. She said she would forward my question to the City Attorney. She also gave me examples of where neighborhoods buy commercial property and then sell it to developers for residential use.

What this means to me, is that if I want to vote "No", I won't be intimidated into voting "Yes".

As for the \$1000.00 Exxon will contribute to the Constable Program, compare that to the \$600.00 the Garden Oaks Baptist Church gives. Is this a good deal? I don't think so.

I checked with Susan McMillian, Garden Oaks Board of Trustees President, about who gets to vote on this issue. She said it would be limited to Section One residents only.

I'm sure there will be a lot more said on this issue in the months to come, but that's all I have to say on it for now.

As for being the editor and an officer, I appreciated the opportunity to serve. I am pleased that the membership saw fit to approve my proposed Bylaw changes, and I hope that the changes remain positive. To the incoming president, I hope he reads and understands the

Bylaws, and runs the Civic Club according to their intent. This makes it possible for different personalities to work together for a common cause... the enhancement of Garden Oaks. As long as I'm wishing and hoping, how about some Roberts Rule of Order too?

To the new editor I recommend attending every membership meeting possible, to be able to report on the affairs of the club and to make sure the minutes and budgets are accurate before being published.

Thanks for all the encouraging words and the cooperation i've received. I wish you all a wonderful holiday season and a great new year!





LEAD IN YOUR HOME

Lead pipes used in ancient Rome are still intact today. Many scholars now believe that the heavy use of lead by the Roman citizens contributed to the low birth rate, strange behavior and subsequent fall of their empire. A frustrated Ben Franklin realized the effects of lead in painters and printers of his day. but could not convince the public of his observations. A recent study by Dr. Herbert Needleman linked elevated lead blood levels with delinquent and antisocial behavior in Pittsburgh boys. Unfortunately, the lead problem has been with us a long time, and it won't go away on its own.

Children are at the heart of the threat since even low levels of lead can result in behavioral problems, learning disabilities, and even permanent brain, nervous system and kidney damage. Lead exposure before or during pregnancy can also alter fetal development and cause miscarriages.

Paint is not a stable medium for lead Lead is hazardous like asbestos, but unlike asbestos, it is used on friction areas like windows and doors. The friction of these areas act to produce a hard-to-see film of dust that can contain lead. In its dust form, lead is better able to be introduced to a young child's respiratory or digestive system. Improper cleaning or renovation frequently makes the problem much worse by dispersing fine lead dust particles in the air and over accessible household surfaces. If managed improperly, both adults and children can receive hazardous exposures by inhaling the fine dust or by ingesting paint dust during hand-to-mouth activities.

This year there are new requirements for the sellers and landlords of housing built before 1978. On Sept. 6, owners of more than 4 residential properties were affected and on December 6 all sellers and landlords of pre-1978 residential property become affected. Simply put, sellers or renters must disclose the presence of known lead based paint or hazards to buyers or tenants. In addition they must distribute the federally approved lead hazard information pamphlet, Protect Your Family From Lead in Your Home, as well as, attach a Lead Warning Statement and get a signed acknowledgment before selling or leasing a residence. (The required federal form is available from the Texas Real Estate Commission's fax -ondemand service. Call 512-419-1623 and enter code 66000004 from your fax machine and hang up. The federal pamphlet can be obtained from the National Lead Information Clearinghouse at 800-424-LEAD.)

Buyers have a 10 day opportunity to get a Lead Inspection before they are obligated to buy. A qualified Lead Inspector will be Certified by the Texas Dept. of Health and use an XRF (X-ray fluorescence) instrument. The XRF method is totally quantitative, nondestructive, covers a large number of surfaces, is very accurate and is HUD and EPA approved. An XRF inspection is needed to notify the concerned homeowners exactly where the lead is. An adequate Risk Assessment should include an XRF Inspection since Risk Assessments concern themselves with visual observation, habits of occupants and dust sampling.

Today's home buyer must be better informed than ever in order to make such an important decision. Special liability risks for landlords are on the rise as public awareness increases. The good news is, there are trained professionals to bring the truth to light.

GARDEN OAKS CIVIC CLUB MINUTES NOVEMBER 5, 1996

President Ed DeAlba opened the meeting by mentioning that the main business items for the meeting would be election of 1997 officers, the covered dish dinner for the December meeting and the Bylaw amendments proposed by Alex Martinez.

The Central Bank is opening new branches in the area. The first location is the old NationsBank on Shepherd and the next one will be at TC Jester and 18th Street.

Area kids have participated in a "Peaceworks" Quilt Project displayed starting November 9 at the Museum of Fine Arts.

Community Business Exxon Rich Stark heads a committee to negotiate the best deal possible with Exxon. Other committee members are Ed deAlba and Kim McMath. The problems are traffic flow, noise and possible vagrancy. There is no entrance planned off 30th St. There will be a 15' sign next to the freeway. The food franchise has not been determined yet. Exxon will contribute \$1,000 per year to the constable program. Craig Lee mentioned that the ongoing negotiations might include Exxon buying the lots to the North of the proposed station. It will be up to Exxon and Trammell Crow Real Estate to come up with the petitions to get a variance to the deed restrictions. The petition would need the signatures of more than 50 percent of the homeowners in Section 1 (one house, one vote). Exxon may be back in December. If so, the separate meeting will be for Section 1 residents only and will be held away from the Garden Oaks Baptist Church.

Education Jane Ann Roberts talked about the Garden Oaks Elementary Fall Festival and Auction on November 10. The auction list was passed out. She recognized Rick Englert for cooking at the pancake breakfast and helping with the auction. The school was recently recognized in Texas Monthly magazine.

There will be a fund-raiser February 14, 1997. It will be a one man play, Chris Drake playing John Henry Faulk, at the Main Street theater. Tickets will include the play, Champagne, hors d'oeuvres and a dessert buffet. The school is also participating in the Kroger share program, where 1% of purchases are contributed to education.

Graham Park Andrea Spiering thanked all those who sent letters to Councilwoman Huey and the parks department. The park should be complete by the end of November.

Home Tour Laura Morgan reported that the committee has already met and are preparing letters to send to potential home tour homeowners. More volunteers are needed for the April 27 event. The goal is to get the neighborhood Realtors involved to have open houses during the tour. The Montessori program will be a focus of the funds raised.

GO Cop Carl Waters reported that there have been 31 crimes in Garden Oaks that have been reported to the Houston Police Department in 1996. 10 in Sec. 1, 9 in Sec. 2, 2 in Sec. 3, 4 in Sec. 4, 1 in Sec. 5 and 5 in Garden Oaks Plaza. There has been some gang activity. Gang graffiti reporting forms were passed out.

Gazette Alex Martinez reiterated that the deadline is the 10th of each month.

Programs Terry Jeanes said that she had positive feedback from the candidates at the October meeting. They know the residents who stayed for the forum are serious and are knowledgeable of the issues important to this area, such as a sound wall and commercial encroachment.

New Business President DeAlba moved on to the 1997 officer elections. The presidential candidates were not published in last month's Gazette.
