Exxon Tiger Mart Update

An Exxon Tiger Mart, consisting of a 2700 square foot convenience store, six multi-product fuel dispensers, car wash, and a possible drive-thru fast food facility, is scheduled to open up October 20, at the intersection of Yale, 30th Street, and W. North Loop 610.

The property, located in Garden Oaks Section 1, though deeded commercial, is bound by deed restrictions imposed for Section 1 & 1A, which prohibits the sale of alcohol on commercial property. Chronological events leading up to the construction are as follows:

- October 1, 1996: Exxon Regional Sales Manager, Frank DeMatiaski, addressed the civic club, along with two members of the Crane family (owners of the property), attorneys from Fulbright & Jaworski, and Trammell Crow real estate. Exxon asks for a variance to the alcohol deed restriction. Exxon was told that they would have to obtain the okay from over 50% of the Section 1 homeowners for the variance.
- January 17, 1997: Exxon gets approval from the Garden Oaks Board of Trustees for the physical layout of the Exxon plan, but Board gives Exxon no approval for the alcohol variance.
- May 14, 1997: Exxon applies for construction permits from the City.
- August 18, 1997: Construction of Exxon Tiger Mart begins.
- August 28, 1997: Research begins, with the help of Helen Huey's office, to see if Exxon applied for an alcohol permit. No permits found. Huey's office red flags any future permits with the county and the TABC.
- August 29, 1997: Exxon invited to September 2 Civic Club meeting. Exxon declines.
- September 2, 1997: Helen Huey speaks to Dave Gardner, Exxon Media Relations, and gets verbal assurance from Mr. Gardner that "no alcohol would be sold at this location."
- September 6-7, 1997: Exxon questionnaire, developed by civic club, dropped off to Section 1 & 1A homes requesting input and announces September 10th meeting to discuss the Exxon issue further. Questionnaire asks: "Would you as a homeowner allow the sale of alcohol by Exxon in exchange for concessions benefiting Garden Oaks?"
- September 10, 1997: Section 1 & 1A homeowner meeting at GO Elementary. Sixty plus homeowners in attendance. Fifty six homeowners vote "no alcohol sales under any circumstances."

President's Message

My tenure as president is drawing to a close. I've enjoyed the work and the friendships, but to quote past president Ed de Alba, "two years are too many." It's now time to hand over the reigns to the next administration.

Therefore, the call goes out to anyone interested in serving as an officer. If you are interested or if you want to suggest someone, contact me. The election of officers takes place in November.

Candidates for City Council. Various candidates vying for Helen Huey's seat will be at our October meeting.

New Meeting Place. Members voted at the last meeting to move our meeting location from GO Baptist Church to GO Elementary School. Move will take affect for the December meeting. The school is centrally located and offers the facility free-of-charge. Parking will be in the teacher's parking lot. The move has nothing to do with our current host, GO Baptist Church. The church has been very good to us and we thank them for their support.

Neighborhood Connections Conference. Conference was held at UofH on Saturday, September 6. I attended the sessions on deed restrictions, fund-raising, and community-based organizations. There was also a nice write-up about the de Albas as our "Neighbors of the Year." The important thing I learned was: Neighborhood projects need lots of money. The key is dedicated people willing to work hard to make a vision a reality. The woman who envisioned and brought about the park at Heights @ 7th, spoke on how she and a small circle of volunteers raised \$90,000 for the park.

Section One Residents-Deed Restriction Issues. The two lots east of Conn's were sold to Mr. Conn. Lots are designated as residential, and I will contact Mr. Conn to see if he has any immediate plans.

On the other end, an Exxon station is being built, and they will not be able to sell alcohol unless

Section One homeowners grant a variance.

Homeowners were given a questionnaire and meeting notice on their doorsteps last month. The GOCC officers wanted to find out how many people were willing to vote for such a variance in exchange for concessions from Exxon, such as a donation for the constable program, higher walls between the station and the adjoining residences, closing 30th street where station begins, etc.

Before a variance is possible, 50% of Section One homeowners need to agree. I received 54 questionnaires, more than 10%. Of those, 24 were willing to allow alcohol sales in exchange for concessions, 26 said "no alcohol sales under any circumstances," and four either took no position or found the questionnaire confusing.

More importantly, of the 60 plus people attending the September 10th meeting at GO Elementary, only four (counting me), were in favor of such a variance. Everyone else was against it. **I'm convinced.**

The GOCC officers will meet with an Exxon representative in the next week and we will ask them as "good neighbors" to help the community with various things, but our marching orders on the alcohol issue are simple: **NO HOW, NO WAY.**

As for closing 30th street, that is a matter that may not concern Exxon at all. There are those strongly for it and those equally against it. I do not live on 30th, so it is not for me to take on that question. I will, however, put anyone interested in touch with people who know more than I about whether or not such a proposal is realistic, and if so, where to start.



Garden Oaks Civic Club Minutes

President Bennett Bartlett called the September 2nd meeting to order at 7:06 p.m. Officers present: Bennett Bartlett, Craig Lee, Andrea Spiering, Sheila Briones and Ray Housley. Council member Helen Huey was also present. There were 72 members in attendance. Bennett opened the meeting with a brief explanation of the Exxon issue in Section 1. Exxon was invited to address the civic club but declined.

Speaker. Ralph Smith from the Near North Advisory Council spoke about the council role and the Differential Response Unit (DRU). First year was spent on building out the DRU facility. Officers at the DRU are Bart Jandal and Richard Hetmaniak and can be reached at 713-956-3152 or 713-956-3153. The main number is 713-956-3140. During Q & A, area gang activity was discussed specifically the graffiti near the tennis courts at Graham Park. The DRU and HPD Gang Unit are aware and watching it closely.

Exxon. In April 1997, the board of trustees and the civic club considered the Exxon station to be a dead issue as no waiver for alcohol was given for the deed restricted property. In August 1997, construction begun on permits given by the city for a 2700 square foot facility to include a gas station, car wash, convenience store and drive-through fast food restaurant at the corner of Yale & 30th street. No records of application for alcohol permits have been found to date. Construction is

to be completed by Oct. 20, 1997.

Helen Huey stated that her office had found no record of any TABC permits filed with the state, local, county or city levels. Huey spoke with Dave Gardner, media relations for Exxon. Gardner stated that Exxon was not going to sell alcohol at this location. When asked to document "no alcohol would be sold" in writing, he did not decline but has not come forth with such documentation. Ms. Huey promised continued support to enforce our deed restrictions and to ensure the peace and morals of our neighborhood. Discussion followed concerning the board of trustees, traffic on 30th, legal requirements for deed restriction waivers, etc. The effect that Taco Cabana and Gabby's have on our legal rights was also discussed. Both sell alcohol for on site consumption and are in Section 1. The conclusion of the lawyers in attendance was that this would have no effect on our efforts to block the sale of alcohol by Exxon, if this is the desire of Section 1 homeowners.

An Exxon committee was formed at Bennett's request consisting of himself, representing GOCC, Ed de Alba representing the Board of Trustees, and Alex Martinez representing Section 1 homeowners. They will put together a flyer and contact Section 1 residents for a consensus and/or meeting to discuss this issue in depth.

On the recommendation of Helen Huey, the civic club will send a letter to Mayor Lanier and to the TABC reminding them of our deed restricted neighborhood and the violation of those restrictions by Exxon. This was approved by proclamation by those in attendance.

Treasurer. Ray reported \$7,400 was paid out for beautification; an unknown amount was received for trees and shrubs for the esplanade. A check for \$1,700 was presented to the Garden Club from proceeds of the home tour. Also checks for \$850 each will be given to GO Elementary and the Friends of Montessori from home tour proceeds.

Beautification. Brenda de Alba reported that paperwork is progressing on the city grant awarded for the GO Boulevard esplanade project. Thanks to the volunteers involved in preparing the site and installing the bollards and walkway. Work days are planned for October when trees will be planted from TreeSearch Farms.

Terry Jeanes offered a \$500 challenge. If the civic club raises \$500 in donations earmarked for Beautification, she will match it with

Citizens on Patrol. Carl Waters reported four crimes in June and three in July. John Hessey was patroller of the month for July; Mr. & Mrs. Kelly were for August. Volunteers needed for mid-afternoon and early evening shifts.

Education Liaison. Jane Ann Roberts reported that a pancake breakfast to benefit the Montessori program at GO Elementary will be held in October. There are 616 students enrolled and most grades are capped. There are several new teachers, and a new librarian.

An Issues Forum will be held on Sept. 29 to discuss a Montessori Middle School format. Bennett noted that other schools with GO residents are welcome at civic club meetings.

Garden Club. Janice Walden reported that shumard oak trees are still available for purchase. Next garden club meeting is scheduled for Sept. 11 at Janice's home and the topic will be salvias.

Constable Program. Bennett reported that the committee approach will be used to run the constable program during the year.

New Business

Neighborhood Conference. Bennett discussed a conference to be held Saturday, Sept. 6, 1997, for neighborhoods to learn more about deed restrictions, safety, traffic, etc. Brenda and Ed de Alba have been nominated for Neighbors of the Year.

Property near Conn's. Mr. Pryor sold his two lots next to Conn's on 30th to Mr. Conn. Lots purchased with the full knowledge that they are deeded residential.

Change in Meeting Location. Garden Oaks Elementary has offered its multi-purpose room for our monthly civic club meetings. After discussion on parking, kid-care rooms, a more central location within the neighborhood, etc., a motion was made to move meetings to the school beginning with the installation of new officers at the December meeting. The motion passed unanimously. It was noted that the *Gazette* offers free advertising to GO Baptist Church where the meetings have been held and that this would continue as it does for all area churches.

Save Our Neighborhoods (SON). A representative from SON came to the last executive meeting of the officers of GOCC asking us to join. After discussion on the focus of this neighborhood civic group alliance - the removal of sexually oriented businesses in different areas of Houston - the officers turned down their request. If group should move to schools, safety, parks or traffic issues, GOCC would then reconsider its position. Meeting adjourned at 8:40 p.m. Refreshments provided by Terry Jeanes.

GO-COP Readies for Holiday Season

Residents Can Help Prevent Criminal Acts

We have had a couple of criminal acts this month. Either late September 2 or early September 3, two vehicles were reported burglarized. No forced entry was used and cellular telephones and other items were taken. If your car is parked in the driveway, lock the doors and use a club. Do not, for any reason, leave valuables in your car. Install an audible alarm, if you can afford it.

To the residents who have a gate across your driveway leading into a garage or back yard area: if the gate is constructed of wood or anything that I can not see through, secure the gate with a lock. Burglars will and do open the gate, pull their vehicles in, close the gate and wipe you out. You can either secure it closed or opened, as long as the burglar can not hide behind it.

Those who have dark spots around their homes' exteriors: install lights. Best ones are motion detector lights that turn on when someone or something passes in the light area. Lights can be purchased at Home Depot and are not very expensive.


