## ORDER DENYING TRUSTEE'S OMNIBUS OBJECTION TO CLAIMS [Relates to Docket No. 167]

Upon the objection (the "Objection") of the Chapter 7 Trustee (the "Trustee") for entry of an order (this "Order") sustaining the Omnibus Objection, all as more fully set forth in the Objection and the Declaration of the Chapter 7 Trustee, Randy Williams; and finding that:

- 1. this Court has jurisdiction over this matter pursuant to 28 U.S.C. § 1334;
- 2. this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2);
- this Court may enter a final order consistent with Article III of the United States Constitution;
- 4. venue of this proceeding and the Objection in this district is permissible pursuant to 28 U.S.C. §§ 1408 and 1409;
- the remaining claimants (identified on the attached Schedule) each adopted the arguments and basis for equitable relief asserted by Michael Falick as the sole ground to support each of the filed claims;
- 6. notice of the Objection and opportunity for a hearing on the Objection was appropriate under the circumstances and no other notice need be provided.

The Court additionally read findings of fact and conclusions of law into the record, and based upon the findings and conclusions in this Order and on the record, it is

**ORDERED** that the Objection is overruled with respect to the claims identified on the attached schedule, and it is further

**ORDERED** that Claims identified on the attachment in the amounts stated are allowed as general unsecured claims, and it is further

**ORDERED** that due to the modification of the claims at the hearing, the allowance of the claims as general unsecured claims in no way prejudices the right of Garden Oaks Maintenance Organization, Inc., to assert the claims/defenses contained in the omnibus objection as to any claims other than those reflected on the attached Schedule in this proceeding; the Court makes no finding as to the viability of those claims/defenses of Garden Oaks Maintenance Organization, Inc.
