

## I would change the GOCC priorities by....

- Taking on HOA functionality as top priority.
- I would keep the existing priorities, but we urgently need a deed restriction enforcement entity. We are missing GOMO.
- Fundraising is vital to our stated goals
- Replace beautification (because so much great work was accomplished in 2020) with Fundraising. If we do not raise additional funds for GOCC to offset low GOCC Membership we will be bankrupt within 10 years.
- Fundraising is a necessity if we want improved security (more than one Constable) and ongoing beautification
  efforts. Can GOCC partner with GO Kids to come up with more creative fundraisers? Should cater to the wide
  range of residents here young kids, older adults, those with pets, etc.
- All items listed are a priority. Safety, security of our valuable property covered by the Constable program as well as GOMO monthly meetings (in person) and social functions are all important to us living in Garden Oaks.
- moving fundraising up in priority, specifically the fundraising for the Constable program.
- prevent the taller homes by somehow adding a maximum height to deed restrictions. two have already made it past the "city enforcers" because they said the third story is an "attic" with windows, and real stairs.


- Adding more fundraising so we can support the other 3 priorities.


